

- 2 Replaceing three (3) existing Aerator Control panels with three (3) new 100 Amp, 3 phase, 3 Wire, 480 Volt, Nema 3R Panelboards. Each Panelboard will be furnished with five (5) 3 pole 15 Amp Breakers.
- 3 Furnishing and installing nine (9) new Aerator Controllers. New Aerator Controlers will be designed and furnished by Reliant Water Technologies to ensure compatability with the new Aerators.
