

**ORDINANCE NO. \_\_\_\_\_**

**An Ordinance to Adopt the Recommendation of the Zoning Commission Regarding  
Expansion of the Hammond Historic District**

---

**Whereas**, on December 1, 2015 the Mayor of the City of Hammond appointed a Study Committee to review, consider and recommend whether the Hammond Historic District should be expanded; and

**Whereas**, the Study Committee has recommended the expansion of the Historic District and issued its report dated September 22, 2016 to the Hammond Planning and Zoning Commission on the historic significance of the buildings, structures, sites, monuments, areas and landmarks in the area proposed to be added to the Hammond Historic District; and

**Whereas**, on November 3, 2016 the Planning and Zoning Commission has conducted a public hearing on the proposed expansion of the Historic District after having posted a notice of the purpose, time and place of the public hearing; and

**Whereas**, The Planning and Zoning Commission after review and consideration of the report from the Study Committee has voted as follows: 2 members in favor of expansion of the Historic District and 3 members against expansion of the Historic District and has presented its final written report to the Hammond City Council on December 13, 2016.

**Now Therefore, BE IT ORDAINED** that the Hammond City Council hereby adopts the recommendation of the Planning and Zoning Commission that:

1. The Hammond Historic District should not be expanded. Hammond Ordinance #14-5364 is upheld in its current status and the Unified Development Code, Section 8.1.7 Definition of the Historical District, and all other places where the definition appears, will remain the same as currently adopted.
