

INTERGOVERNMENTAL AGREEMENT

This agreement is executed between the **CITY OF HAMMOND**, hereinafter referred to the "City" represented by its Mayor, Pete Panepinto, authorized by Resolution adopted on the ____ day of _____, 2017, and the **TANGIPAHOA PARISH SCHOOL BOARD**, a political subdivision of the State of Louisiana, domiciled in the Parish of Tangipahoa, herein represented by its Superintendent, Mark Kolwe pursuant to a directive of the Board of Supervisors of the said Tangipahoa Parish School Board dated _____, 2017, hereinafter referred to as "School Board".

Whereas, the parties desire to enter into an Intergovernmental Agreement for the use and lighting of Reimers Field within Zemurray Park in Hammond:

Whereas, Hammond High School has three baseball (hardball) teams (Varsity Baseball, Junior Varsity Baseball, and 9th Grade Baseball), hereinafter collectively referred to as "HHS Baseball, requiring the use of the Reimers Field for its 2017 season;

Whereas, both parties desire to promote a quality athletic and recreation program for the student athletes and community and to provide the Hammond High School with an appropriate and lighted facility for the HHS Baseball practices and games for its respective 2017 seasons, and consequently, agree to the stipulations and conditions for use of Reimers Field in Zemurray Park in the manner outlined below and to insure the citizens of Hammond and students of Hammond High School a quality baseball facility for its 2017 HHS Baseball seasons:

- A. The City grants to the School Board for the exclusive use of the HHS Baseball program the Reimers Field baseball facility with its adjoining concession stands and storage areas located in Zemurray Park in Hammond during the 2017 HHS Baseball season including any and all playoffs for its scheduled games and practices. This exclusive use shall remain in full force and effect beginning February 1, 2017 and shall expire on April 23, 2017 or on the last day of any and all 2017 playoff games in which the HHS Baseball program participates.
- B. HHS Baseball's exclusive use shall begin three hours before each scheduled game, as provided in the attached schedules of games, or rescheduled game due to weather or other reason, and at the scheduled time of a HHS Baseball practice.
- C. It is further understood by the parties that the facility will be maintained by the City and all expenses in connection with the use and maintenance, including utilities are to be borne by the City. The School Board does, however, agree to the regular clean up of the facility, including concession stands following each use and to clean out all storage areas at the expiration of this Agreement.
- D. The School Board shall furnish a valid certificate of insurance to the City providing insurance coverage for any injuries sustained by participants or spectators pertaining to the performance of this Agreement.
