

COOPERATIVE ENDEAVOR AGREEMENT

This Cooperative Endeavor Agreement is entered into by and between:

THE CITY OF HAMMOND, represented herein by its duly authorized and empowered Mayor, by the authority given in Resolution No. _____ (the "City"); and

HAMMOND AIR SHOW FOUNDATION, INC., represented herein by its duly authorized officer, _____, (the "Foundation");

who declare and agree as follows:

WHEREAS, Article VII, Section 14(c) of the Constitution of the State of Louisiana provides that "for a public purpose, the state and its political subdivisions ... may engage in cooperative endeavors with each other ... or with any public or private association, corporation, or individual"; and

WHEREAS, the City is a home rule charter government, having all powers not denied by its charter or by general law or inconsistent with the constitution, including but not limited to the specific authority to exercise general police power, as well as to pass ordinances to promote, protect and preserve the general welfare, safety, health, peace and good order of the City; and

WHEREAS, the City is authorized by its home rule charter to enter into joint service agreements or cooperative efforts with other governmental agencies and political subdivisions and private entities for a public purpose; and

WHEREAS, the Foundation is charitable non-profit corporation to promote the use and growth of the Hammond Northshore Regional Airport, to encourage more participation in the field of aviation, and to enhance the quality of life in Hammond and the surrounding area by providing an air show and related functions; and

WHEREAS, the City acknowledges and desires to promote the purposes of the Foundation, instill commerce in the Hammond Northshore Regional Airport, and increase tourism within the City of Hammond; and

WHEREAS, the Foundation desires to enhance the activities and events and attract participation at the Hammond Northshore Regional Airport; and

WHEREAS, this collaborative effort shall yield benefits to all City residents and participants and promote the general welfare through enhanced aviation activities and promotion of the City of Hammond and the Hammond Northshore Regional Airport; and

WHEREAS, the parties agree the obligations and terms of this Agreement will further the purposes of City and the Foundation.

NOW THEREFORE, in consideration of the covenants and agreements hereinafter set forth to be kept and performed by the parties hereto, it is agreed by and between the parties as follows:

SCOPE OF AGREEMENT

This Agreement shall be effective for __ years. The parties are under no obligation to renew this Agreement for future years, but may do so if agreed and duly authorized by both parties in writing.

OBLIGATIONS OF THE PARTIES

1. The Foundation agrees to promote the use and growth of the Hammond Northshore Regional Airport, to encourage more participation in the field of aviation, and to enhance the quality of life in Hammond and the surrounding area by providing an air show and related functions and activities at the Airport.

2. Participation fees for each activity undertaken pursuant to this Agreement and the allocation of the fees to the City and the Foundation shall be agreed by the City and the Foundation.

3. With the approval of the Mayor, the City will provide necessary personnel, facilities, support, and supplies to the Foundation so it can perform its obligations under this Agreement and consistent with its mission and purpose.

4. The Foundation will pay for the expenses related to its activities, except the City may provide maintenance and clean-up costs. The Foundation shall provide security.

5. Each party shall maintain liability insurance providing coverage for its respective actions for each activity undertaken pursuant to this Agreement. Each party shall provide a copy of such policy to the other upon request.

MUTUAL AND RECIPROCAL BENEFIT

The Foundation and City acknowledge and agree that the obligations and agreements of each are in consideration of the obligations and agreements of each other and are of mutual value

INDEMNIFICATION

To the extent allowed under any policy of liability insurance and to the fullest extent permitted by law, the City shall indemnify and hold harmless the Foundation, its respective officials, employees, insurers and agents from and against any claims, liabilities, injuries, damages and costs (including reasonable attorney's fees and costs of defense) arising out the actions of the City, its officials, employees and agents undertaken pursuant to this Agreement.

To the extent allowed under any policy of liability insurance and to the fullest extent permitted by law, the Foundation shall indemnify and hold harmless the City, its respective

officials, employees, insurers and agents from and against any claims, liabilities, injuries, damages and costs (including reasonable attorney's fees and costs of defense) arising out the actions of the Foundation, its officials, employees and agents undertaken pursuant to this Agreement.

AUDITING AND FINANCIAL RESPONSIBILITY

Each party shall be allowed to audit all aspects of the operations of the other for each activity undertaken pursuant to this Agreement. Each party shall maintain accurate books and records of the operations of such activities for at least three (3) years and shall deliver such records to the other upon request.

Each party shall maintain copies of all complaints or other written comments received from participants of each activity undertaken pursuant to this Agreement and shall produce such documents to the other upon request.

This Agreement does not impose any financial obligation on the City or the Foundation, except as specifically set forth herein.

CONTROLLING LAW

The validity, interpretation and performance of this Agreement shall be controlled by and construed in accordance with the laws of the State of Louisiana.

LEGAL COMPLIANCE

Each party shall comply with all federal, state, and local laws and regulations with respect to the operation of the League and compliance with the obligations of this Agreement.
