Re: Nominations for Hammond Downtown Development District (HDDD) Authority Vacancies

Dear Mr. Marshall:

According to the Downtown Development Authority's enabling legislation, "Two members shall be appointed from nominations submitted by property owners subject to the ad valorem tax provided for in Subsection E of this Section, or who are licensed business owners within the district. Nominations shall be compiled separately for the areas east and west of the ICG Railroad tracks, and each such nominee shall be nominated by a minimum of five business owners" There is one vacant seat on the Board belonging to the Eastside property owners.

To qualify for nomination, the legislation requires that:

All taxes and licenses of all nominees as well as those placing names in nomination must be current. Each member of the DDD Authority shall own property in the district or shall be a business owner within the district, or be an officer of a corporation or other business entity owning property in the district and shall be a registered voter in Tangipahoa Parish.

From among the nominations submitted to the Downtown Development District Board, the following meet this criteria:

• Pierre Theriot, Holly & Smith

After reviewing the nominations, the Board would like to recommend the appointment of Pierre Theriot (bio attached). Pierre Theriot has served as the DDD Vice Chairmen and Design Committee Vice Chairmen, and remains a vital member to our organization. We believe he will continue to serve the DDD very well.

The world of design and construction has always been a part of Pierre Theriot's life. Growing up, his father managed a lumberyard and later became a general contractor.
