"Statement of Revenue and Payment of Tax. Not later than twenty (20) days after March 31, June 30, September 30 and December 31 of each year, each licensee shall furnish the City with a duly verified statement indicating total coins in, credited played, credits won and credits paid, in a form approved by the City. The tax due the City as provided in section (k) of this ordinance shall be remitted by the licensee to the City with each statement of revenue."

Sec. 6-39. (k): delete the last sentence of this section and replace with the following:

"Twenty-five percent (25%) of the taxes collected by the City from electronic video bingo shall be placed in a dedicated fund solely for the funding needs of a children's museum operated by the City or operated through a cooperative endeavor agreement with the City."

# An Ordinance to amend the City of Hammond Ordinance #21-35 Simple Battery to include section 21-35.23

Sec. 21-35.3.

- A. Domestic abuse battery is the intentional use of force or violence committed by one household member upon the person of another household member without the consent of the victim.
- B. For purpose of this Section:
- (1) Community service activities: as used in this Section may include duty in any morgue, coroner's office, or emergency treatment room of a state-operated hospital or other state-operated emergency treatment facility, with the consent of the administrator of the morgue, coroner's office, hospital or facility.
- (2) "Household member" means any person of the opposite sex presently living in the same residence or living in the same residence within five years of the occurrence of the domestic abuse battery with the defendant as a spouse, whether married or not, or any minor child presently living in the same residence or living in the same residence within five years immediately prior to the occurrence of domestic abuse batter, or any biological minor child of the offender regardless of where the child resides.
  - (C) On a first conviction, notwithstanding any other provision of law to the contrary, the offender shall be fined not less than three hundred dollars nor more than one thousand dollars and shall be imprisoned for not less than ten days nor more than six months. Imposition or execution of sentence shall not be suspended unless:
  - (1) the offender is placed on probation with a minimum condition that he serve two days in jail and participate in a court-approved domestic abuse prevention program, and the offender shall not own or possess a firearm throughout the entirety of the sentence; or
  - (2) The offender is placed on probation with a minimum condition that he perform four eight-hour days of court-approved community service activities and participate in a court-approved domestic abuse prevention program and the offender shall not own or possess a firearm throughout the entirety of the sentence.
  - (D) On a conviction of a second offense, notwithstanding any other provision of law to the contrary, regardless of whether the second offense occurred before or after the first conviction, the offender shall be fined not less than seven hundred fifty dollars nor more than one thousand dollars and shall be imprisoned for not less than thirty days nor more than six months. At least forty-eight hours of the sentence imposed shall be served without benefit of parole, probation, or suspension of sentence. Imposition or execution of the remainder of the sentence shall not be suspended unless:
  - (1) The offender is placed on probation with a minimum condition that he serve fifteen days in jail and participate in a court-approved domestic abuse prevention program and the offender shall not own or possess a firearm throughout the entirety of the sentence; or
  - (2) The offender is placed on probation with a minimum condition that he perform thirty eight-hour days of court-approved community service activities and participate in a court-approved domestic abuse prevention program, and the offender shall not own or possess a firearm throughout the entirety of the sentence.

## AN ORDINANCE FOR AMENDMENT TO CHANGE AVERAGE LOT SIZE AND LOT WIDTH IN NEW SUBDIVISIONS

## BE IT ORDAINED by the City of Hammond that:

SECTION 1. Amend to change average lot size and lot width in new subdivisions

## AMENDMENTS TO LOT SIZE (65ft)

## AMENDMENTS TO ZONING AND/OR SUBDIVISION ORDINANCE FOR THE CITY OF HAMMOND

# The following changes listed below in items 1-6 apply to all residential developments except those within R-8 and R-11 zones:

**1. CHANGES IN LOT SIZE**: New residential single family subdivisions that are minor or major subdivisions or resubdivisions shall have a minimum of 50 foot wide lots measured at the front property line (except on cul-de-sacs where 50 ft width is measured at the front set back line) and an average lot width size of at least <u>65</u> feet. These requirements do not include existing lots already legally approved by the City and recorded in the Clerk of Court's office or lots located within R-8 or R-11 zones, which have their same lot width and size requirements.

**<u>2. MINIMUM SQUARE FOOTAGE</u>**: The minimum square footage of these lots shall be 5000 square feet with an average square footage of at least 6500 square feet.

**<u>3. MINIMUM FRONT and SIDE SET-BACK</u>**. Those lots smaller than 65 feet shall have a front building set-back of at least 25 feet. Staggered front setbacks are encouraged the minimum side set-back shall be 8 feet.

**4. PARKING SPACES:** At least 2 paved parking spaces must be provided for each singlefamily dwelling. A paved parking pad of at least 16 ft. wide by 20 ft. on private property must be provided by the builder or owner for each house to hold at least 2 vehicles. Interior garage or carport parking spaces will be considered as additional parking spaces if used in addition to the 2 outside required spaces.

5. COMMON GREEN/COMMUNITY SPACE: All new major subdivisions exceeding 2 acres in size (including portions of larger phased developments) shall include common green area(s) that is at least 5% in size of the property involved, that is accessible to all residents of the subdivision, and that is maintained by the developer, or a property owner's association, or a conservation Foundation (this property can be in the form of a tax deductible conservation easement). These common areas are not to be developed or sold for private benefit but may include playground or recreational features available to the subdivision property owners or residents. A maintenance fund shall be established by the developer with a method of collecting funds from property owners to maintain the green area or community area.

**<u>6. UNDERGROUND SERVICES</u>** Electrical, phone and cable services from the main line service poles to the living unit (service connection) will be underground.

# The following changes listed below in items 7 and 8 apply to <u>all</u> residential developments regardless of zoning category:

7. MINIMUM DRAINAGE REQUIREMENTS: All new subdivision plans shall include detailed drainage plans and topographic plats submitted for review by the City. It is also *recommended* that developers include in their private subdivision standards and restrictions, the requirement for roof drains (gutters) on lots smaller than 65 feet wide, and the use of swales or underground drains to bring rain water to the nearest appropriately sized storm

drain.

**8. MINIMUM RIGHT OF WAY:** The minimum public right of way for roads/streets shall be 50 foot wide for use of City utilities in which subsurface drainage is provided in the right of way and 60 foot wide where subsurface drainage is not provided. An additional 10 feet of utility servitude adjacent to the public right of way shall be provided for non-City utilities such as electric, cable, and gas.



## AN ORDINANCE TO PROHIBIT THE SOLICITATION OF FUNDS ON PUBLIC PROPERTY

WHEREAS, the City of Hammond desires to maintain public order and public safety and;

WHEREAS, the solicitation of funds on public property threatens public order and public safety and the prohibition of such solicitations is necessary to provide for the safety, health and general welfare of the citizens of Hammond and the Hammond community.

NOW, THEREFORE, BE IT ORDAINED BY the City Council of the City of Hammond that ordinance Number 2323, C.S. 1, 11-16-93 is repealed in its entirety and Article VI, Section 28-74, et. Seq., of the Code of Ordinances shall hereafter provide as follows:

### 

## ARTICLE VI. PROHIBITION OF SOLICITATION OF MONEY ON PUBLIC PROPERTY

Sec. 28-74. Definitions.

(a) As used in this section, the following words or phrases shall have the following meaning, unless the context in which the word or phrase is used clearly indicates that a contrary meaning is intended:

#### Individual shall mean any natural person.

Money shall mean and include any thing of value, including any commodity or currency such as coins, cash and negotiable paper notes and bills issued by a government as legal tender.

*Person* shall mean any, group, club, association, organization, charitable organization, corporation or any individual acting on behalf of any such entity.

*Public Property* shall mean the public highways, roads, sidewalks and streets in the city whether owned and/or maintained by the city, parish or the state, and shall also include the rights-of-way and neutral grounds adjoining said highways, roads, sidewalks and streets.

Solicit or Soliciting shall mean an attempt by an individual to collect or receive money from another person or persons, whether or not in exchange for other goods, wares or property.

Sec. 28-75. Prohibition. No person or individual shall solicit for money on public property.

Sec. 28-76. Enforcement provision, violations, penalties.

(a) Law enforcement officers of the city are authorized to ascertain the authority by which an individual or person purports to be soliciting money on public property.

(b) Any individual or person soliciting money on public property of the city shall be charged with a misdemeanor violation punishable by a fine not to exceed five hundred dollars (\$500.00) or imprisonment in the city jail for a period not to exceed sixty (60) days, or both, at the discretion of the court.

AND MINNESOTA PARK ROAD PROPERTIES INSIDE OR OUTSIDE OF, OR BEING ANNEXED, BY THE CITY OF HAMMOND, AND CONNECTING TO CITY UTILITY SERVICE AND FOR THE PURPOSE OF ESTABLISHING A SEWER/WATER IMPACT FEE RELATED TO THE EXTENSION OF WATER OR SANITARY SEWER MAINS/SERVICES

## BE IT ORDAINED by the City of Hammond that:

## 1—PURPOSE

The purpose of this ordinance is to impose a fee (hereinafter referred to as the "Impact Fee") for the costs incurred to construct/extend City of Hammond sanitary sewer collection mains/services or potable water/fire protection lines to accommodate various developed and undeveloped properties in this area of new utility services. The area included is shown in the attached Figure 1.

## 2-AFFECTED PROPERTIES/BUILDINGS

Those affected properties subject to the Impact Fee are those in which the owner or developer proposes to construct homes, multi-family units, storage, commercial or institutional buildings or connect existing buildings to the public utility improvements. The impact fee would be paid to the City of Hammond Building Department at the time of application for a building permit or utility connection service. In the case of existing buildings being connected, the impact fee will be paid to the Building Department before utilities are connected.

Properties or buildings only requesting fire protection service lines from the City must also be tied into City potable water service lines (rather than using a private well or Rural Water District lines).

## **3--AMOUNT OF IMPACT FEE**

- The amount of the impact fee imposed for water and/or sewerage service shall be as follows:
- a. Single Family Units Homes: \$800 per unit
- b. Apartments/multi-family and duplexes (this includes nursing homes, fraternities or other types of group quarters: \$500 per rental unit or rental space
- c. Business/commercial structures: \$1000 per water closet

## **4--METHOD OF COLLECTION**

The impact fee shall be assessed and collected concurrent with the obtaining of a building permit or utility permit at the time of application for said permit, for all buildings which are being built or will connect to City of Hammond services.

## 5--DISPOSITION OF IMPACT FEE PROCEEDS

The Impact Fees collected as a result of this ordinance shall be placed in a utilities Enterprise Fund or escrow account, and shall be disbursed only for the purposes of upgrading, constructing, tying in, operating, and improving the City of Hammond Water or Sanitary Sewer system.

# 6--CLARIFICATION OF FUTURE ASSESSMENT PURPOSES

The Impact Fees assessed and collected shall not prohibit nor limit the authority of the City of Hammond to assess the residents/property-owners the "inside" or "outside" water usage rates based upon the property's inclusion or exclusion from the City corporate limit boundary.





THESE CODES ALSO RELATE TO THE SAFE, SANITARY, AND HEALTHFUL OCCUPATION AND USE OF BUILDINGS AND STRUCTURES

#### **SECTION 1**

WHEREAS, it is the desire of the City of Hammond to adopt, in all respects, excluding fee schedules, the various Building and Construction Codes (i.e. the State Uniform Construction Code/Building Code) relating to building, fire prevention, gas, housing, mechanical, plumbing, and swimming pools and;

WHEREAS, the adoption of these codes is done to facilitate proper inspection activities by the City relating to construction and to maintenance of buildings within said City and relating to public safety, health and general welfare:

NOW, THEREFORE, BE IT ORDAINED BY the City Council of the City of Hammond that the following codes as adopted by the State of Louisiana, and as updated hereinafter by the State, are hereby adopted by reference as though they were copied herein fully:

-International Building Code excluding Chapters 27 (Electrical), 28 (Mechanical) and 29 (Plumbing) without Appendices A, B, D, F, and H -International Residential Code for 1 and 2 Family Dwellings -International Existing Building Code, excluding Parts 1 (Administration), Part V (Mechanical), Part VII (Plumbing), and Part VIII (Electrical) -National Electric Code -International Mechanical Code -Part XIV (14) of the La. State Plumbing Code -International Fuel Gas Code

The previous codes that exceeded these codes are hereby repealed. Nothing in this ordinance or in the Uniform Construction /Building Code hereby adopted shall be construed to affect any suite or proceeding impending in any court, or any rights acquired, or liability incurred, or any cause of causes of action acquired or existing, under any act or ordinance hereby repealed as cited in Section 1 of this ordinance; nor shall any just or legal right or remedy of any character be lost, impaired, or affected by this ordinance.

#### **SECTION 2**

That the Hammond Council Clerk's Office shall certify to the adoption of this ordinance, and cause the same to be published as required by law; and this ordinance shall take effect and be in force from and after its approval as required by law.

#### **SECTION 3**



#### AN ORDINANCE CREATING THE DISASTER EMERGENCY FUND

#### **BE IT ORDAINED** by the City of Hammond that:

#### AN ORDINANCE CREATING THE DISASTER EMERGENCY FUND

There is hereby created a Disaster Emergency Fund for the City of Hammond. This fund is being established for the purpose of maintaining funds available in time of emergency that will be available to assist with recovery efforts of the City of Hammond.

This Fund may be used for the purpose of payment of necessary expenses to expedite the return of the City to normalcy following a natural or man-made disaster. Such expenses may include the payment of overtime; the purchase of needed supplies; the providing of temporary locations of city functions; for contractual agreements between the City of Hammond and other parties, such agreements to be approved for the purpose herein intended as established under guidelines of the City; or for other uses established by the Mayor.

No funds shall be expended except under the following circumstances: (1) the declaration of a disaster including Hammond, LA, by the President of the United States; (2) the declaration of a disaster including Hammond, LA, by the Governor of the State of Louisiana; (3) the declaration of a disaster by the Mayor of the City of Hammond; AND (4) the approval of a majority of the Hammond City Council authorizing the use of the Fund.

This Fund may be abolished or reduced for use for non-emergency disaster purposes only by regular ordinance and only upon a vote of 2/3 of the Council.

The initial funding for the Disaster Emergency Fund shall be one million dollars (\$1,000,000) provided for from Sales Tax Surplus funds. Interest earned on the account shall inure to the benefit of the Fund and shall be applied according to financial standards established by the City.

#### AN ORDINANCE TO APPROVE ENTERGY FRANCHISE AGREEMENT

Upon the request of Entergy Louisiana, LLC, (the "Company"), and pursuant to La. R.S. 33:4401, this municipality's police powers, and in order to protect the health, safety, and welfare of the public, the City of Hammond, Louisiana, (the "Municipality") as set forth herein below grants to the Company, its successors and assigns, a franchise, right, and privilege for a period of twenty-five (25) years from the date of adoption hereof, to distribute, deliver, sell and supply, in such a manner as it chooses, electric service throughout the Municipality, and to the inhabitants thereof, or to any person, firm, or corporation; the right to acquire, construct, operate, and maintain such plants, structures, transmission lines, distribution systems, cables, fibers, facilities, and equipment as may be useful or necessary for the generation, production, transportation, distribution, delivery and/or sale of electric service throughout the Municipality; the right to erect, operate, and maintain poles, masts, supports, wires, cables, fibers, transmission lines, conduits, conductors, substations, distribution systems, and any and all other appliances useful or necessary in connection with the sale, transportation, delivery and/or distribution of electric service on, over, under, along, upon, and across all of the present and/or future streets, roads, highways, alleys and public places of the Municipality; the right to repair, replace or remove same or any portion thereof; and the right to connect any such facilities to any other such facilities for the purpose of selling, transporting and/or distributing electric service into through, or beyond the boundaries of the Municipality.

**SECTION 1:** Be it ordained by the Mayor and City Council of the Municipality in regular session duly convened, that the Municipality grants and there is hereby granted to Entergy Louisiana, LLC (the "Company"), its successors and assigns, in addition to the rights and privileges presently enjoyed by the Company, a franchise, right, and privilege from the date of adoption hereof.

- (1) To distribute, deliver, sell and supply electric service throughout the Municipality and to the inhabitants thereof, or to any person, firm, or corporation, in such manner and from such sources as the said Company chooses;
- (2) To acquire, construct, operate, and maintain such plants, structures, transmission lines, distribution systems, cables, fibers, facilities, and equipment as may be useful or necessary for the generation, production, transportation, distribution, delivery and/or sale of electric power and energy throughout the Municipality;
- (3) To erect, operate, and maintain poles, masts, supports, wires, cables, fibers, transmission lines, conduits, conductors, substations, distribution systems, and any and all other appliances useful or necessary in connection with the sale, transportation, delivery and/or distribution of electric service on, over, under, along, upon, and across all of the present and/or future streets, roads, highways, alleys and public places of the Municipality;
- (4) To repair, replace or remove same or any portion thereof; and
- (5) To connect any such facilities to any other such facilities for the purpose of selling, transporting and/or distributing electric service into, through, or beyond the boundaries of the Municipality.

SECTION 2: Be it further ordained that this Franchise does not authorize the Company to use its facilities for the transportation, distribution, or sale of electric service for or on behalf of third parties to any person, firm, or corporation other than the Company located within the boundaries of the Municipality, unless and until the Company has been notified, in writing, by the Municipality that the interests of the Municipality, including, but not limited to, its recovery of franchise fee revenue on such third party transactions, are adequately protected in connection with the provision of such third party service by the Company. In the event that the

operations of the Company are unbundled, in connection with the adoption of a plan for retail open access or otherwise, the Company will have the right to assign its franchise rights with respect to particular facilities or operations as may be necessary to facilitate unbundled operations; provided, however, that any such assignment (1) shall not result in a reduction in the franchise fees received by the Municipality relating to the provision of electric service within the Municipality; and (2) shall ensure that the Municipality retains all other rights and protections afforded by this Franchise.

**SECTION 3:** Be it further ordained that this Franchise is granted upon and subject to the following provisions:

A. In maintaining its properties, the Company shall not unnecessarily or unreasonably damage, impair or obstruct the streets, roads, highways, alleys, sidewalks, and public grounds, and the Company shall at its own expense, without unreasonable delay, make all necessary repairs to remedy any damage or remove any obstruction caused by its operations hereunder, all in accordance with applicable industry standards. The Company shall obtain all necessary permits or approvals for construction, maintenance, and operations; provided, however, that this provision shall not apply to any requirements for such permits or approvals that are adopted or amended subsequent to the date of this Ordinance and that, as so adopted or amended, have a material effect on the Company's rights or obligations pursuant to this Franchise or on the Company's cost of providing service pursuant to this Franchise.

B. Upon request, the Company will make its best reasonable efforts to provide current maps for specific areas showing feeder routes and the majority of pole locations, and will provide construction manuals that show the typical structural configurations used by the Company; provided, however, that the provision of such information by the Company shall not

relieve the Municipality of any obligations that it may have pursuant to title 40, section 1749 or title 45, sections 141-146 of the Louisiana Revised Statutes or any related or successor statutes; and provided that such information shall be provided by the Company without any warrant as to its accuracy.

C. The Company shall use reasonable precautions to avoid damage or injury to persons or property, and shall hold and save harmless the Municipality from all damages, losses, and/or expense, including cost of defense, attributable to the negligence or fault of the Company, its agents or employees, while exercising any of the rights and privileges herein granted.

#### **SECTION 4:**

- A. In consideration of the facts:
- (i) That the Company, pursuant to this Ordinance holds a good, valid, and irrevocable twenty-five year franchise granted by the Municipality; and
- (ii) That, to the extent the Company is permitted by law to provide such service, the Municipality has signed with the Company contracts for the purchase of all its electric service requirements, each of which contracts is for a period of two years from its date, or such longer period as may be required by the applicable rate schedule or other circumstances, and provides for periodic renewals for similar periods unless notice of termination is given as therein provided;

and other good and valid considerations, the Company agrees that it will pay to the Municipality a sum of money equal to two percent (2%) of the gross receipts of the Company from the sale of electric service at retail for residential and commercial purposes within the corporate limits of the Municipality (the Company's "gross receipts"), such payments to be calculated on such receipts commencing with the month of  $Mun_{equal}$ , 2006 the first payment to be due and payable

on the 10 h day of 10 h, 2000 subsequent payments to be due quarterly thereafter.

B. Further, upon the adoption of an appropriate Ordinance, the Municipality may require that the Company pay to the Municipality up to an additional two percent (2%) of the gross receipts of the Company from the sale of electric service at retail for residential and commercial purposes within the corporate limits of the Municipality (the "Additional Franchise Fee"). The Company shall include in its franchise fee calculation such Additional Franchise Fee commencing with respect to gross receipts received by the Company pursuant to bills rendered during the first calendar quarter following the adoption of an appropriate Ordinance, and the receipt of written notification from the Mayor of the Municipality. Pursuant to the October 18, 1988, General Order of the Louisiana Public Service Commission ("LPSC"), the Company shall collect from residential and commercial customers located within the corporate limits of the Municipality such additional percent of gross receipts as is not included in the Company's base rates through a line item included in bills rendered for electric service. The Company agrees that, in the event the LPSC approves the recovery of the Additional Franchise Fee through base rates, the Company shall remove the line item notation relating to the Additional Franchise Fee from the bills rendered to customers for electric service at such time as base rate recovery of the Additional Franchise Fee becomes effective.

C. It is distinctly understood and agreed that the percentage of gross receipts paid to the Municipality shall not apply to or include any receipts from the sale of electric energy to the Municipality, or to Government or Municipal Agencies, or to any sale for industrial purposes or for resale within the corporate limits of the Municipality. It shall be the responsibility of the Municipality to notify the Company of any annexations or other changes in the corporate limits

of the Municipality, so that the Company can make any adjustments to its gross receipts calculation that may be necessary as a result of such a change.

D. This obligation to make such payments to the Municipality shall remain in full force and effect so long as (1) the Company holds a good, valid and irrevocable twenty-five (25) year franchise granted by the Municipality, and (2) the Municipality, to the extent permitted by law, purchases all of its electric service requirements from the Company; provided, however:

- This contract is wholly and entirely conditioned upon the approval (i) of the Treasury Department of the United States of America and the Department of Revenue of the State of Louisiana, and upon the approval of the Louisiana Public Service Commission of the right of the Company to deduct from its gross revenues and charge as an operating expense any and all amounts which it may pay to the Municipality pursuant hereto other than such amounts as may be collected from customers through a line item on customer bill and in the event of failure to obtain the approval of any such authority for such purpose, the Company shall have the right to cancel this Contract upon thirty (30) days' notice; it being understood that in the event of the cancellation by the Company upon the grounds set out in this paragraph, the Company shall not be entitled to any refund of any monies theretofore paid to the Municipality pursuant hereto.
- (ii) Should the Municipality levy any new taxes, of any nature whatsoever, subsequent to the date of this Contract, or increase the rates of any taxes in existence on the date of this Contract (except uniform ad valorem taxes now authorized by Article VII, Section 18 of the Constitution of the State of Louisiana or other taxes that are generally applicable to all businesses in the Municipality), then the payments herein provided to be made by the Company to the Municipality will be reduced in an amount equal to the sum of such new and increased taxes, if any. The Additional Franchise Fee shall not be considered to be a new tax or an increase in the rate of a tax for purposes of this provision of the Ordinance.
- (iii) To the extent the Company is permitted by law to provide to the Municipality all of its electric requirements, in the event that retail open access is implemented in Louisiana, and is adopted for the Municipality, the obligation of Entergy Louisiana, LLC to pay a franchise fee as set forth hereinabove shall cease to be conditioned on the purchase by the Municipality of all of its electric requirements from Entergy Louisiana, LLC

E. In the event that the Company contracts with any town or municipality to pay a franchise fee more than four percent (4%) of gross receipts (includes fuel adjustment) of the Company from the sale of electric service at retail for residential and commercial purposes, the Company, upon the adoption of an appropriate Ordinance, and upon the receipt of written notification from the Mayor of the Municipality, will increase the franchise fee paid to the Municipality by an amount which will equal the difference between four percent (4%) and the said higher amount paid to the other town or municipality; provided, however, that the Municipality shall have the right to increase the franchise fee to such higher amount only in the event that the Municipality is willing to accept all other terms and conditions of the franchise franchise fee calculation said increase in the franchise fee commencing with respect to gross receipts received by the Company pursuant to bills rendered during the first calendar quarter following the adoption of an appropriate Ordinance, and the receipt of written notification from

the Mayor of the Municipality. In no event shall the Municipality have the right to increase the franchise fee to an amount in excess of five (5%) percent or such other amount as may established as a limitation on the application of the provisions set forth in title 33, section 4510 of the Louisiana Revised Statutes or any successor statute regarding the recovery of franchise fees. Any amount in excess of four percent (4%) shall be passed on by the Company to the residential and commercial customers in the Municipality as a line item on their bills for electric service to the extent that such treatment is afforded the Additional 2% Franchise Fee paid pursuant to Section 4(B), above.

F. The Municipality shall have the right, upon reasonable notice, to review the available data and calculations upon which the franchise fee calculations are based; provided that such notice must be received within three (3) years of the beginning of the period to which the data and/or calculations pertain.

SECTION 5: Be it further ordained that the Municipality shall make, adopt and enforce all ordinances necessary to protect the property and property rights of the Company owned and operated under this Franchise, while still recognizing the rights of any other entities holding valid franchises with the Municipality, and that the Municipality will not in any way interfere with the full legal use by the Company of the property which it now maintains or may hereafter maintain in the Municipality.

**SECTION 6:** Be it further ordained that this Ordinance, the public health and welfare and the public necessity requiring it, shall take effect from and after its adoption. Notwithstanding the foregoing, the Company shall file with the Municipality the Company's written acceptance of this Ordinance not later than thirty (30) days from the date of its passage.

**SECTION 7:** Be it further ordained that this Franchise shall be for a term of twenty-five (25) years from date hereof, and upon exercise by the Company of any of the privileges granted hereunder, this Franchise shall be irrevocable. If either the Municipality or the Company, its legal representatives, successors, or assigns, institutes any action or proceedings to enforce the provisions of this Ordinance, the parties hereby agree that specific performance may be sought and obtained for any breach of this Ordinance, without the necessity of proving actual damages; provided, however, that either party may, at its option, waive its right to specific performance and collect damages resulting from any breach hereof or failure to perform hereunder.

SECTION 8: Nothing in this Franchise shall be construed as superseding, repealing, canceling, modifying, or in any way affecting any of the rights enjoyed by Entergy Louisiana, LLC under that certain franchise granted by Ordinance No. 892, C.S., adopted by the Municipality on the 5<sup>th</sup> day of August, 1980, and said franchise is hereby recognized as continuing in full force and effect in accordance with its terms. However, in the event of a conflict between said franchise and this Franchise, the provisions of this Franchise shall be controlling.

SECTION 9: Nothing herein shall be construed to constitute the grant of a franchise for the provision of any service other than electrical service to customers within the Municipality.

WHEREUPON, in open session said Ordinance was read and considered section by section and as a whole.

## AN ORDINANCE ESTABLISHING REQUIREMENT FOR DESIGNATION OF MUNICIPAL PROPERTY ADDRESSES AND USE OF STREET NAMES

- SECTION 1: **Purpose** In order to promote and maintain public safety and welfare it is necessary to take steps to reasonably assure efficient and prompt emergency response services to the citizens of Hammond.
- SECTION 2: Address Numbering— Municipal property addresses for properties without existing addresses must be obtained from the City's Building Department. Proper municipal street addresses, which the City coordinates with the Parish 911 Communication District, shall be obtained from the GIS (Geographical Information Systems) Section of the City Building Department before a property owner, tenant, or business owner uses and posts such address.
- SECTION 3: Address Visibility—Municipal address numbers must be posted clearly and visibly on the building and on a street side mailbox when used. Address numbers must be visible from the nearest street to the building. Therefore, the minimum height for address numbers is 3 inches.
- SECTION 4: New Street Names— New street names within the City must be approved by the City Building Department. The City of Hammond shall have final authority over street names in cases of duplications or similarities. The City Planner checks for this when plans are submitted for review,

**Section 1:** The Hammond city council declares that in order for the City of Hammond to remain competitive with private employers and to maintain a skilled and experienced work force, the City shall provide a twelve percent (12%) pay increase to all full time regular City employees, both exempt and non-exempt, effective at the first payroll period of fiscal year 2006/07.

**Section 2:** This increase shall only apply to exempt and non-exempt full time regular City employees employed by the City as of the commencement of the 2006/07 fiscal year and shall be computed based on the employee's salary as of June 30, 2006.

**Section 3:** This increase shall apply to Louisiana State Supplemental pay received by eligible firefighters and police officers.

**Section 4:** There shall be no additional CPI increase added to the salary of City employees for the fiscal year 2006/07. Longevity (anniversary) increases shall continue to be provided for City employees for the fiscal year 2006/07 in accordance with the existing City pay plan ordinance.

Section 5: The Mayor is authorized and directed to revise the City pay plan pay grid effective July 1, 2006 for the pay grade classifications for City employees reflecting this twelve percent (12%) increase.

### SETTLEMENT AGREEMENT

In cooperation with members of the classified civil service employed by the City of Hammond in the Fire Department ("Firefighters") and Police Department ("Police Officers") and their representatives, in matters relating to their wages and their assertion of various claims relating to the computation of and payment of certain components of pay allegedly mandated by La. R.S. 33:1992 B, La. R.S. 33:2002, La. R.S. 33:2218.2 and other laws;

The City of Hammond ("City") acting through its Mayor and its City Attorney, have discussed, with the assistance of the Federal Mediation & Conciliation Service, an amicable resolution of the disputed claims;

The parties hereby agree to the following terms and conditions:

1) The City will pay to all Firefighters and Police Officers who are members of the classified civil service and eligible to receive Louisiana State Supplemental Pay ("Eligible Members"), retroactive to July 1, 2000, accrued amounts (compounded annually) attributable to the 2% longevity increases or anniversary increases mandated by La. R.S. 33:1992 B (as to eligible Firefighters) or Hammond Ordinance No. 2000-2692, C.S. (as to eligible Police Officers), applied to the monthly Louisiana State Supplemental Pay received by Eligible Members at any time from July 1, 2000 through May 1, 2006 and will continue to apply said longevity or anniversary increases to Louisiana State Supplemental Pay consistent with all applicable ordinances currently adopted or which may be adopted or amended in the future and State law as it currently exists or as it may be amended or modified in the future.

2) The City will pay to all Eligible Members retroactive to July 1, 2003, accrued amounts (compounded annually) attributable to the annual Consumer Price Index (CPI) increases

awarded to each such employee by operation of Ordinance No. 2000-2692, C.S., applied to the monthly Louisiana State Supplemental Pay received by Eligible Members at any time from July 1, 2003 through May 1, 2006 and will continue to apply such CPI increases to State Supplemental Pay consistent with all applicable City ordinances currently adopted or which may be adopted or amended in the future and State law as it currently exists or as it may be adopted or amended in the future. These CPI increases shall be calculated on State Supplemental Pay for Eligible Members in the same manner as CPI increases are calculated by the City for all non-civil service City employees.

3) The City will establish and administer a revised pay grid for Eligible Members, which shall incorporate the pay computation and payment obligations established in paragraphs 1 and 2 above.

4) The City will make all necessary contributions to the retirement systems which Eligible Members have participated in during the retroactivity periods established above with respect to all reconstituted payments made pursuant to this Agreement

5) The City agrees to provide Firefighters and Police Officers a proposed itemization of payouts to Eligible Members at least 30 days prior to the effective date established in Section 10 of this Agreement to afford all parties the opportunity to assess the accuracies of such computations and correct errors, if any.

6) The Mayor agrees to publicly recommend and support a CPI increase for Firefighters and Police Officers for Fiscal Year 2006-2007.

7) All parties agree to recommend and support the terms of this Agreement.

8) The parties agree that any Firefighter or Police Officer receiving a payment under this Agreement must, as a condition to receiving such payment, execute a "receipt and release"

and waiver of claims in a form agreed to by counsel for all parties.

9) The parties agree that this Agreement shall not result in any duplicative payment to any Firefighter or Police Officer who has previously received CPI increases or longevity or anniversary increases on Louisiana State Supplemental Pay during the time periods referenced herein.

10) It is agreed that the effective date of this Agreement as to the payment obligations described herein will be April 6, 2006, subject to the final adoption of an appropriate ordinance by the Hammond City Council.

## "AN ORDINANCE AMENDING ORDINANCE NO. 2515, C.S. AND ORDINANCE NO. 2421, C.S. UTILITY RATES"

# BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HAMMOND, LOUISIANA, AT ITS REGULAR SESSION HELD ON THE 7<sup>TH</sup> DAY OF FEBRUARY 2006.

#### ADDITIONS Definitions Section:

Deferred Billing from Operations—The monthly usage for months prior to the enactment of this ordinance for which charges will be carried for until later billing periods. Such Deferred Billing may be incorporated in the rate structure of the city from time to time as enacted by the Council.

## Formula for determining Sewer and Water Rates:

Following the annual independent audit of the city financial report, the Independent Auditor shall determine the actual cost of operation of the Sewer and Water Department for the previous year by totaling all operating expenses. In order to calculate the Water and Sewer rate, the Independent Auditor shall add to that figure any anticipated (budgeted) increase in the cost of operating, the scheduled amount of upcoming Annual Bond Principal and Interest payments, required Bond Reserve payments, and a contingency fee (not to exceed 10 of total operating expenses), Annual Capital Outlay for the Water and Sewer Department for the upcoming year, any amounts to be considered as Deferred Billing from Operations, minus Surplus Cash. That shall be divided by the total number of Gallons Sold to customers of record as of the end of the fiscal year in order to determine the minimum rate per gallon for providing Water and for the calculation of the Sewer Treatment Fee. The Independent Auditor shall, using generally accepted governmental accounting principles, report to the Council and the Administration, in writing and not later than 90 days following the audit, what the monthly rate will be for the upcoming year. This rate formula should, at a minimum, provide net revenues after operating expenses exclusive of depreciation and interest paid on bonded indebtedness in each year equal to 130% of the bond principal and interest payments in that year.

In calculating the minimum rate to be paid, a minimum usage of 2,000 gallons shall be charged.

#### AN ORDINANCE REGARDING AN ATTEMPTED DEDICATION OF A RIGHT OF WAY DECLARING THAT THE CITY HAS REJECTED THE ATTEMPTED DEDICATION

**BE IT ORDAINED** by the Hammond City Council that:

Section 1: This Council has become aware of the filing of an act dated July 5, 1956 (the "Act") purporting to dedicate a street across certain property to be used for public use (the "Property"). The Act is recorded at COB book 220, page 48 of the records of the clerk of court of Tangipahoa Parish.

Section 2: In truth and in fact, no street has been constructed on the Property described in the Act. The Property is currently owned by private landowners and is in use by the landowners.

Section 3: There is no record of an acceptance by the City of the Property. The Property is not necessary for public use. Therefore the City declares and it does hereby reject the purported dedication of the Property.

Section 4: The recordation of the Act constitutes a cloud on the title of the Property and limits the merchantability of the Property. It is in the public interest that this cloud be removed and the public be made aware of the City's rejection of the purported dedication.

Section 5: Accordingly, Mayson Foster, Mayor of the City of Hammond or his designee, is authorized to execute on behalf of the City an appropriate act of rejection of the purported dedication of the Property and any other document reasonably required to evidence this action of the Council.

1. Lessor and Lessee intend that the lease of Tract 1 shall be for the entire term of the lease; Tract 2 and Tract 3A are leased temporarily until such time as Lessee declares that it has no further use of either or both tracts, but in no event beyond the earlier of (a) completion of the permanent facility by Lessee, or (b) January 30, 2011, without the written consent of Lessor.

2. This agreement is subject to the following terms and conditions:

(1) The term of this lease shall be for ninety-nine (99) years commencing from the following date: January 3, 2006.

(2) The parties acknowledge that the annual consideration of one dollar (\$1.00) has heretofore been paid in advance for the entire term of the lease, receipt of which is hereby acknowledged by Lessor. In the event of a default by Lessee or other termination of this lease, any advance rent paid by Lessee shall be retained by Lessor as fair compensation.

(3) The Lessor hereby covenants and agrees to permit Lessee or any agency or unit thereof to erect upon the Leased Premises such hangers, shops, supply warehouses, armories, garages, administrative buildings and other such structures, including such ramps, pads, vehicle parking, fencing, sidewalks, driveways and ingress and egress as may be required by Lessee or any agency or unit thereof as may be necessary to support the operation of an Aviation Support Facility or those facilities deemed necessary to further the activities of Lessee, subject to the terms and conditions set forth herein.

(4) Title to all structures erected upon the Leased Premises shall remain in the Lessee. Upon termination or expiration of this lease, in whole or in part as to any part or individual Tract comprising a part of the Leased Premises, Lessee reserves the right to remove all structures and upon request of Lessor, Lessee shall restore the Leased Premises to its original condition as of the commencement of this lease as near as may be under the circumstances then existing.

(5) Lessor further covenants and agrees to permit Lessee or any agency or unit thereof to use the ramps, runways and other facilities existing or hereinafter established at the Hammond Northshore Regional Airport as may be required by Lessee, its agencies or units, subject to the limitations described hereafter.

(6) Lessor and Lessee agree that Tract 2 and Tract 3A are leased temporarily until such time as Lessee has constructed the facilities on Tract 1 necessary to support the operation of an Aviation Support Activity and/or until such time as Tract 2 is not required for temporary housing for Lessee's personnel.

(7) Lessee leases the Leased Premises with the understanding that the preexisting lease/rental of the private aviation facility/T Hangers in Tract 1 along with the rights and privileges attached thereto shall remain in effect until such time as a replacement facility has been prepared and Lessor instructs its tenants to relocate to the new facility.

(8) In the event the use of the Leased Premises described herein by Lessee, at any time causes congestion of air traffic at the Hammond Northshore Regional Airport, and thus materially interferes with the operation of commercial aviation traffic, Lessor reserves the right to require Lessee or any agency or unit thereof, to readjust its flying schedule and flying operations, including the use of runways and facilities so as not to unduly interfere with commercial operations or endanger the same.

(9) Lessee agrees that its use of the Leased Premises shall at all times comply with all rules and regulations of the federal government regarding Lessee's use and operation of the Leased Premises, including the Federal Aviation Authority or its successor agency.

(10) Lessor and Lessee agree that this Lease shall be cancelled in the event Lessee fails to use the leased premises for military purposes for a period of five consecutive years. In the event Lessee determines that the facility shall no longer be used for such purposes, it may accelerate the five year period through the execution of an event of Cancellation

(11) Any improvements to the Hammond Northshore Regional Airport, including on the Leased Premises shall be subject to the approval of provisions of form 7460-1 by the Federal Aviation Administration.
