**ORDINANCE NO. 18-5546 C.S.**

**An Ordinance to amend Rule V-24 (E) Travel, regarding meal allowance, of the Personnel Policies and Procedures Manual for City Employees**

BE IT ORDAINED by the Hammond City Council that Rule V-24 (E) Travel, regarding meal allowance, of the Personnel Policies and Procedures Manual for City Employees shall be amended to read as follows:

+++++

E. Business Meal Allowance.

Meals purchased by an employee for City business are reimbursed differently for single day travel versus overnight travel. Meals purchased by an employee for City business will be reimbursed according to the General Services Administration Rates (available at [www.gsa.gov](http://www.gsa.gov) website) which are in effect at the date of travel. Meal receipts are not required but the dates and meals claimed (breakfast, lunch, and dinner), including the City business purpose for the meals, must be documented on the travel reimbursement form.

Meal per diem is only paid after the travel with the correct documentation attached to a completed travel reimbursement form. A copy of the conference agenda, training or business schedule and the approved travel request form must also be submitted with the travel reimbursement form. If a meal is included as part of the conference, training or business registration, then the value of the provided meal will be deducted from the per diem.

For single day travel, one meal may be reimbursed if the travel exceeds six hours. The time of travel will determine which meal (breakfast, lunch or dinner) is reimbursed. Meals purchased by an employee during single day travel for City business will be treated as income received by the employee. As such, income taxes will be deducted from the reimbursement amount.

During overnight travel, meals purchased by an employee for City business will be reimbursed per diem. The first and last calendar dates of the travel are calculated at 75% of the per diem for that day.

If an employee has a special diet need due to a documented health condition and necessary meals or accommodations cannot be met by meals provided during the conference or training, the employee will be reimbursed per the allowable rate. Documentation that the special diet is required must be signed by a physician or similar medical provider and shall be provided prior to the travel. Documentation should be provided to the Human Resources Director so that verification notice may be sent to the Department Head.

**ORDINANCE No. 18-5547 C.S.**

**An Ordinance to Regulate Filming and to Provide for Filming Permits**

BE IT ORDAINED by the Hammond City Council that Chapter 19 (Licenses, Permits and Miscellaneous Business Regulations) shall be amended to add Article X, Sections 280-296 to provide for the regulation of filming and filming permits to read as follows:

+++++

**ARTICLE X. FILMING ACTIVITY**

**Sec. 19- 280 Purpose of Ordinance.** It is the purpose of this Ordinance to provide specific rules governing the issuance of permits for filming motion picture, television, commercial and non-theatrical filming activities on location within the city. The intent of this Ordinance is to ensure that still photographers and motion picture, television, commercial and non-theatrical filming companies will be encouraged to use locations for filming activities within the city so long as those activities are consistent with public health, safety and welfare, and the protection of property.

**Sec. 19-281 Definitions.** As used in this Ordinance:

"Applicant" means the person, organization, corporation, association or other entity applying for a permit to film in the City of Hammond.

"City" means the City of Hammond as a municipal corporation and existing pursuant to the laws of the State of Louisiana.

"Filming Activity" means the staging, shooting, filming, videotaping, photographing, or other similar process conducted for the making of still photographs, motion pictures, television programs, video games, commercial and nontheatrical film productions.

"Filming Commercials" means and includes all activity attendant to the filming of an advertisement (commonly referred to as a "commercial") which is produced and paid for by an organization or person, which conveys a message, typically to market a product or service.

"Film Permit" means written authorization from the City to conduct the Filming Activity described in the permit.

"News Purposes" means a Filming Activity conducted for the purpose of reporting on persons, events, or scenes which are in the news for newspapers, television news, and other news media.

"Permittee" means the person, organization, corporation, association or other entity issued a film permit under this policy.

"Public Street" means any street or road maintained by the City and located within the City limits.

"Still Photography" means and includes all activity attendant to staging or shooting commercial still photographs.

"Student Filming Activity" means Filming Activity conducted to fulfill a course requirement by a student enrolled at a public or private school.

"Studio" means a fixed place of business where filming activities are regularly conducted upon the premises.



**Sec. 19-282. Permit Required.** A permit must be issued by the City for the purpose of filming on City-owned, leased or controlled real property or City streets. This permit must be in the possession of the Permittee at all times while on location in Hammond.

This permit does not constitute or grant permission to use or occupy property not owned, leased or controlled by the City. An Applicant shall obtain the private property owner's permission, consent, and/or lease for use of property not owned or controlled by the City.

**Sec. 19-283. Permit Exemptions.** The provisions of this ordinance shall not apply to any of the following activities provided that the activity will not require the closure of a public street, or substantially impede vehicular traffic thereon:

- A. Filming Activities conducted for News Purposes as defined in Section 19-281;
- B. Filming Activities conducted at Studios as defined in Section 19-281;
- C. Filming Activities conducted for use in a criminal investigation or civil or criminal court proceeding;
- D. Filming Activities conducted as Student Filming Activity as defined in Section 19-281;
- E. Noncommercial filming activities conducted solely for private or family use;
- F. Commercial Still Photography or staging thereof;
- G. Filming Commercials as defined in Section 19-281 involving less than five (5) total persons in the production;
- H. Filming Activities conducted by or for the City.

**Sec. 19-284. Deadline for Filing Applications.** Applications for a Film Permit must be filed with the City a minimum of five (5) business days in advance of the date the Film Activity is to begin.

No late applications will be processed by the City unless the City determines that special circumstances exist relative to the application which would have precluded its application on a timely basis.

Applicants are encouraged to submit applications at the earliest advance date possible in order to facilitate coordination between City departments.

Upon such a showing of good cause, the City shall consider applications which are filed after the filing deadline if there is sufficient time to process and investigate the application, and for city staff to prepare for the Filming Activity.

**Sec. 19-285. Application Form.** The permit application shall be on a form furnished by the City signed by the Applicant or authorized agent thereof. Such form may include, but not be limited to, the following information:

- A. Name, address, and telephone number of Applicant;
- B. Name, address, and telephone number of person in charge of filming on location;
- C. Filming location(s), dates and approximate daily call times of proposed Filming Activity;
- D. The proposed name of the film/series, subject matter and primary actors;
- E. Description of scenes to be filmed including details of any hazardous Filming Activity employing firearms, explosives, the use of open flame, other

pyrotechnical effects, animals, stunts, filming of moving motor vehicles or aircraft;

- F. Description of the types and number of motor vehicles which will be parked on public streets, and description of any equipment to be placed on public property;
- G. Description of the types of City services requested such as water, electricity, map coordination, recycling, garbage collection and disposal, security and lighting.
- H. Evidence of adequate insurance certification as stipulated by Section 19-290;
- I. Such other information as the City may require.

#### **Section 19-286. Permit Approval/Denial.**

A. The application shall be approved or denied within five business days of receipt of the application unless the proposed Filming Activity requires extensive review by other City departments due to fire, traffic or public safety. The Film Permit shall be approved by the City unless determined from consideration of the application or other pertinent information that any of the following conditions exist:

- 1. The Filming Activity will substantially disrupt the use of a street at a time when it is usually subject to traffic congestion, or interfere with the operation of emergency vehicles in the proposed permit area.
- 2. The Filming Activity will substantially disrupt nearby businesses or residences or other major events.
- 3. The location of the Filming Activity will substantially interfere with street maintenance work, or a previously authorized work permit.
- 4. The proposed permit location is on City property and the Filming Activity will substantially interfere with other previously authorized activities, contracts or safety of the public or citizens while on City property.
- 5. The proposed permit location is on City property and the Filming Activity will substantially interfere with municipal functions or the scheduled maintenance of City buildings or grounds.
- 6. The Filming Activity creates a substantial risk of injury to persons or damage to property.
- 7. The Applicant failed to complete the application or the information contained in the application is found to be false in any material detail.
- 8. The particular Filming Activity would violate federal, state, or local law including licensing or permit requirements.

B. When the grounds for permit denial can be corrected by imposing reasonable permit conditions, the City may impose such conditions rather than denying the permit.

**Sec. 19-287. Permit Conditions.** The City may condition the issuance of a Film Permit by imposing reasonable requirements concerning the time, place, manner and duration of Filming Activities as referenced on any "Terms and Conditions" that may be attached to the Film Permit, including but not limited to, the following:

- A. Requirements for the presence of employees of the City at the Applicant's expense, when required for the particular Filming Activity;
- B. Requirements concerning posting of no parking signs, placement of traffic control devices, and employment of traffic and crowd control monitors at the Applicant's expense;



- C. Requirements concerning posting of the outer boundaries of the Filming Activity, and providing advance notice and reasonable compensation to affected property owners and businesses;
- D. Requirements concerning the cleanup and restoration of public streets and City property employed in the Filming Activity;
- E. Restrictions concerning the use of City employee services, vehicles, and other equipment in the Filming Activity;
- F. Requirements that the Applicant pay all fees, deposits and obtain all permits and licenses required for the Filming Activity under local, state and federal law;
- G. Restrictions on the use of firearms, explosions, and other noise-creating or hazardous devices which disturb the peace;
- H. Restrictions on the use of stunts involving pyrotechnics, open flame, vehicle crashes, or other hazardous materials;
- I. Requirements concerning coverup of police, fire and other official uniforms worn by actors, when the actors are not on camera;
- J. Restrictions concerning the use of city logos, insignias, badges, or decals for filming purposes;
- K. Restrictions on the daily hours the Filming Activity may be conducted within the City;
- L. Requirements concerning the City's receipt of proper acknowledgment for any assistance provided in making feature, television, or commercial productions;
- M. Requirements concerning nondiscriminatory practices for employment.

**Sec. 19-288. Fees.**

- A. The Applicant shall pay a permit fee of \$50.00.
- B. The Applicant for a Film Permit may request that the City authorize a street closure on the Film Permit application; and if approved, the following schedule of fees for City services and use of City property shall apply. These fees may be modified by resolution of the City Council.
  - 1- \$525.00 per street block per day closed within the Downtown Development District
  - 2- \$375.00 per street block per day closed outside of the Downtown Development District.
  - 3- Parking/sidewalks under the following schedule:

<u>Calendar Days</u>	<u>up to 800 sq. ft.</u>	<u>801-1600 sq. ft.</u>	<u>over 1600 sq. ft.</u>
1-5 days	\$60.00	\$125.00	\$245.00
6-30 days	\$125.00	\$185.00	\$370.00

**Sec. 19-289. Change of Filming Activity Date.** Upon reasonable notice by the Permittee in advance of the Filming Activity, the City is authorized to change the date for which the Film Permit has been issued without requiring a new application or permit.

**Sec. 19-290. Insurance Required.** The Applicant for a Film Permit shall procure and maintain for the duration of the Film Activity insurance in the forms, types, and amounts prescribed by the City and provide evidence of such insurance to the City.

**Sec. 19-291. Liability and Indemnification.** Prior to the issuance of the Film Permit the permit Applicant must agree in writing to indemnify and hold harmless the City and its officers,

employees and agents from and against any and all losses, claims, damages and judgments arising from the Filming Activity in a form approved by the City Attorney.

**Sec. 19-292. Duties of Permittee.** The Permittee, and all agents, employees, and contractors of the Permittee at the Filming Activity site within the City, shall comply with the following requirements:

- A. The Permittee shall comply in writing with all "Terms and Conditions" of the Film Permit.
- B. The Permittee shall not conduct a Filming Activity within the City not authorized by the Film Permit.
- C. The Permittee shall comply with instructions of the Hammond Police Department and Hammond Fire Department regarding the Filming Activity.
- D. The Permittee shall comply with instructions made by City employees assigned to regulate the Filming Activity site.
- E. The Permittee shall clean and restore all City-owned, leased or controlled property utilized during the Filming Activity to the same condition as existed prior to the Filming Activity.
- F. The Permittee shall comply with this Ordinance and all other policies and ordinances of the City and state and federal law.

**Sec. 19-293. Pyrotechnics.** In addition to the Film Permit, the Applicant must obtain a fire permit if the Filming Activity includes any special effect or stunt requiring the use of pyrotechnics or any material deemed hazardous, including but not limited to, fireworks, open flames, or explosives.

**Sec. 19-294. Permit Revocation or Suspension.**

- A. Permit Revocation. The City may revoke the Film Permit if the Permittee, or any agents, employees, or contractors of the Permittee fail to comply with the requirements set forth in this Ordinance, or if the City determines after the permit is issued that the permit application was false in any material detail.
  - 1. Notice of the grounds for revocation of the Film Permit shall be provided in writing by the City to the permit Applicant or person in charge at the location of the Filming Activity.
  - 2. Appeals of the permit revocation shall be conducted in the matter specified in Section 19-295.
- B. Permit Suspension. The City may suspend the Film Permit when the Filming Activity poses an immediate hazard to persons or property and the Permittee will not, or cannot, prevent the hazard after being instructed to do so.
  - 1. The grounds for the permit suspension shall be provided in writing by the City to the Permittee within one business day of the suspension.
  - 2. Appeals of the permit suspension shall be conducted in the manner specified in Section 19-295.

**Sec. 19-295. Appeals.** The permit Applicant or Permittee may appeal a permit denial, revocation, suspension, permit condition, insurance/fees requirement or the City's decision not to waive a deadline set forth in this Ordinance. Such appeal shall be filed with the City Clerk's Office not later than five business days after the date written notice of the decision is made. Failure to file timely appeal shall result in a waiver to the right to appeal. The appeal shall be heard by the City Council at a special council meeting within five (5) business days.



The decision of the City Council shall be final.

**Sec. 19-296. Violation - Penalty.** The violation of any provision of this Ordinance shall constitute a civil infraction and shall subject the violator to the monetary penalties imposed under Section 1-8 of the Code of Ordinances. This penalty shall be in addition to any claim by the City under Section 19-291.



**ORDINANCE No. 18-5548 C.S.**

**An Ordinance to Regulate Door to Door Solicitation**

BE IT ORDAINED by the Hammond City Council that Chapter 23 (Peddlers and Hawkers), Article III, section 23-37 and 23-40 shall be amended as set forth below regarding permits for solicitors as follows:

+++++

**ARTICLE III SOLICITORS**

...

**Sec. 23-37. - Same—Application; bond.**

- (a) Any person desiring to engage in business as a solicitor within the city shall make application therefore to the city tax collector or designee stating the name and address of the applicant, the name and address of the person, firm or corporation which he represents, and the kind of goods offered for sale, or the kind of services to be preformed.
- (b) A permit application must contain the following information:
- a. Name, telephone number, date of application, physical address and email address of the applicant.
  - b. A brief description of the product or service to be peddled.
  - c. Name, telephone number, cellular phone number, email address, and physical address of each solicitor.
  - d. Criminal background information on each solicitor.
  - e. Date(s) of activity in the city.
  - f. Location and schedule of solicitation.
  - g. Number of solicitors per day.
  - h. Staff: name of local coordinator or manager, cellular phone number, local address, number of individuals who will be performing licensed/permitted services in the city.
  - i. If a vehicle is being used, a description of the make and model vehicle and a license plate number.
- (c) Such application shall be accompanied by a bond in the penal sum of one thousand five hundred dollars, (\$1,500.00) executed by a surety company authorized to do business in Louisiana in a form approved by the city. Any person aggrieved by the action of any such solicitor shall have a right of action on the bond for the recovery of money or damages, or both.
- (d) Such bond shall remain in full force for a period of ninety (90) days after the expiration of any such license, unless sooner released by the city tax collector.
- (e) Hours of solicitation must be between 8:00 a.m. and 5:00 p.m. when standard time is in effect or between 8:00 a.m. and 7:00 p.m. when daylight saving time is in effect.
- (f) Permittee shall wear a visible identification badge displaying the company name (as applicable), individual name, and photo identification.
- (g) Permittee shall display on his or her person any object provided by the city to clearly and readily identify the individual to other citizens and law enforcement as a permittee.



(h) Solicitation shall immediately cease upon observation of a "no solicitation" sign at the location.

(i) Adverse permit action.

a. Generally. Any permit issued under this section may be suspended or revoked, or otherwise subject to adverse permit action, at the discretion of the City, for any of the following:

1. Subsequent knowledge by the city of any false or misleading statements provided by an applicant on the application form.

2. Fraud, misrepresentation or false statements made during the course of the permitted activity.

3. Subsequent conviction of any offense to which the granting of the permit could have been denied under this chapter.

4. Engaging in any activity prohibited under this chapter.

5. Violation of any law relating to zoning, health, fire, building or safety requirements, or any other Louisiana or federal law or statutory or City ordinance provision.

(j) Upon submission of the application, a permit shall not issue if any of the information contained therein is incomplete, false, misleading or for any of the following reasons:

a. Any person listed on the application is registered on the National Sex Offender Registry.

b. Any person listed on the application has been convicted of a crime of violence as defined by R.S. 14:2 et seq. within the past ten years.

c. Any person listed on the application has been convicted of an offense involving burglary, theft, trespass, criminal damage, mail fraud or wire fraud within the past ten years.

#### **Sec. 23-40. - Violations; penalty.**

Any person, whether acting for himself or for another, who shall engage in or attempt to engage in the business of soliciting within the corporate limits of the city without first furnishing bond and securing a solicitor's license in the manner provided in this article, and in addition thereto paying the license tax due the city for engaging in such business, shall be deemed guilty of a misdemeanor, and, upon conviction, shall be subject to punishment as provided in [section 1-8](#) of this Code. . However, nothing in this section shall be construed to limit the city's available legal remedies for any violation of the law, including without limitation, licensing, sanctions, criminal, civil and injunctive actions. In addition, violations or failure to pay civil fines may result in future permit ineligibility.



**ORDINANCE No. 18-5550 C.S.**

**An Ordinance to Regulate Towing and Wrecker Service**

BE IT ORDAINED by the Hammond City Council that Chapter 20 (Motor Vehicles and Traffic) shall be amended to replace existing section 20-73 to read as follows:

+++++

Sec. 20-73. - Rotating Wrecker Log.

(A) The Chief of Police is authorized and directed to maintain a rotating wrecker log of all tow truck operations and wrecker services desiring to participate in the Rotating Wrecker Log Program ("RWLP") within the City of Hammond.

(1) Every person, firm, corporation or other entity who participates as part of the RWLP, and is engaged in, or associated with the towing, removal or storage of any wrecked, abandoned, disabled or other designated vehicle shall comply with the City of Hammond Code of Ordinances, Police Department General Orders and all applicable state laws and administrative regulations governing the towing and storage of vehicles, including, but not limited to, Louisiana Revised Statute 32:1711, et seq., and Louisiana Administrative Code 55:1901, et seq.

(2) Any towing or wrecker service which does not hold a Hammond occupational license shall be required to obtain both a wrecker permit and have proof of a storage license, for at least six (6) months prior to placement on the RWLP. Application for a wrecker permit shall be to the tax collector for the city in accordance with the City Code of Ordinances. In addition, all applicants for a wrecker permit shall furnish to the tax collector all requirements of the Louisiana Towing and Storage Act and rules promulgated there under. The annual permit fee shall be fifty dollars (\$50.00).

(i) Approved towing or storage companies on the RWLP shall:

(a) Be registered with and maintain a regular place of business in the city of Hammond and/or unincorporated areas of Tangipahoa Parish, and have had a storage license for at least six (6) months. Placement on the RWLP will be determined by the date of receipt of the service operator's application.

(b) Maintain a valid Storage Inspection License and not owe any outstanding fees/fines.

(c) Provide 24-hour service on a 365 day per year basis.

(d) Provide for a maximum 30 minute response time from the time of notification, unless extenuating circumstances exist.

(e) Not be an owner, either in whole or in part, directly or indirectly, of any other tow company in the RWLP.

(f) Not be owned, operated by, or knowingly employ any person who has been convicted of a felony relating to auto theft, vehicle insurance fraud, burglary of a vehicle, possession of stolen vehicles or vehicle parts.



(B) When it is determined that a motor vehicle must be towed, the owner or operator of the vehicle shall be given the option to select a licensed towing company to tow their vehicle, if the requested tow company meets the requirements below. If the owner or operator of the motor vehicle is unable to select, or chooses not to select a particular licensed towing company, or an emergency situation requires the immediate removal of the vehicle, the next available licensed towing company on the RWLP list shall be called to tow the vehicle.

(C) Officers shall not make any recommendations as to what towing company a vehicle operator or owner should use. Nothing contained herein shall establish a contract for hire between the city and the wrecker service. A wrecker driver shall be held to be the legal agent of the towing service, and any verbal or written estimate of the cost of towing services shall be binding on the towing service.

(D) Officers shall honor any vehicle owner/operators request for a specific towing service when:

(1) The tow truck requested meets all the requirements of Louisiana Revised Statute Titles 23, 32, and 47 as well as Louisiana Administrative Code Title 55.

(2) No danger to the public is created in so doing.

(3) The officer's return to duty is not delayed beyond a reasonable amount of time (maximum 30 minutes).

(4) If the owner/operator desires a tow business not on the RWLP, they must be able to provide the accurate name of the tow company and either a phone number or city where located. Officers should make a reasonable attempt to locate the phone number and/or contact the desired tow company with available resources.

(E) Debris from a crash, with the exception of medical waste, shall be removed by the tow truck driver, other towing company employees, or the towing company assignee. The officer will make every effort to ensure that the crash scene is safe and protected throughout the recovery process.

(F) Authorized towing companies shall honor all hold orders for law enforcement officers.

(1) The release of a vehicle or contents shall be authorized by the department storing the vehicle.

(2) An officer who is responsible for storing a vehicle shall complete a vehicle storage, wrecker request and inventory record form.

(3) The towing company shall be furnished a copy of the storage/inventory report by the office at the scene.

(G) Each tow truck and operator shall meet all operational requirements listed in this ordinance, as well as the Police Department General Orders, and those mandated for tow trucks, in Louisiana Revised Statutes Titles 23, 32, and 47 as well as Louisiana Administrative Code Title 55. All tow trucks in the business fleet shall also be equipped with the following:

(1) A heavy duty shop type broom.

(2) At least one (1) shovel.

(3) A fire extinguisher(s) that meets or exceeds standards set forth in the FMCSA 393.95.

(4) Search lights or adequate working lights.

(5) Hand held flashlight (charged).

(6) A minimum of five (5) gallons of environmentally safe absorbent material.

(7) At least one amber rotating or flashing beacon visible at night for 360 degrees at a distance of 1000 feet, under normal atmospheric conditions.

(8) Have all cargo and loose items on the bed secured.

(H) All tow truck operators shall:

(1) Be an employee of the tow company whose services are being utilized.

(2) Possess a valid Louisiana driver's license with the appropriate class.

(3) Be proficient with and have the necessary experience/training in vehicle recovery and towing.

(4) Be able to communicate in English.

(5) Wear a uniform shirt displaying the name of the towing company and driver.

(6) Wear appropriate footwear (no soft footwear).

(I) Each tow truck shall be equipped with communication equipment capable of providing direct contact between Hammond Police Department and the tow company representative. The company representative must have the ability to maintain communications with the tow truck operator responding to a call from the Hammond Police Department. Citizen band radios and pagers are not sufficient equipment for this purpose.

(J) Unless prior arrangements have been made with the Chief of Police or his designee, a tow company operator (or representative) must answer all phone calls for towing services at all times. Failure to answer any phone call may warrant an immediate "one call" suspension from the RWLP list other than the call that was not answered.

(K) The towing service shall determine the method and manner of removing vehicles, and shall exercise due care to limit collateral damage during the towing, recovery or removal operations. Tow truck and /or storage facility owners and operators shall adhere to any lawful orders or direction of a department law enforcement officer.

(L) Prohibitions of Tow Truck Operators.

(1) Rotating or strobe beacons shall not be used except while at the scene of crash, while recovering a vehicle, or while towing a vehicle.

(2) No tow truck owner, agent, employee, or operator shall stop at the scene of a crash, disabled, or unattended vehicle for the purpose of soliciting business, either directly or indirectly; unless the owner or operator of said vehicle has specifically summoned the tow company or its employees or agents to such scene for towing or recovery purposes.

(3) Traversing highways for direct or indirect compensation is prohibited.

(4) No operator shall, without the express authorization of the responsible investigating agency, move any vehicle from a public highway or street or from any public property when such vehicle is abandoned, stolen or damaged as a result of a crash.

(5) EXCEPTION: Notwithstanding the conditions imposed in this section, tow operators may, in emergency cases, move a vehicle involved in a crash, if the movement is necessary to extricate a person from the wreckage or to remove an immediate hazard to life and/or property. Any movement shall be reasonable and necessary.



(6) Operators shall respond to the scene of police investigations only when called by the police or by the owner/operator of a disabled vehicle.

(M) If tow truck operators are unable to respond when summoned by special request by the Hammond Police Department, they must immediately notify the department and shall not summon a substitute. Repeated instances of a tow company failing to respond may subject the tow company to removal from the RWLP.

(N) If a tow truck company (or representative) refuses any request for a tow, without reasonable justification, that may constitute grounds for an immediate "one call" suspension from the RWLP other than the call that was refused. Numerous documented refusals may constitute grounds for longer suspension periods from the RWLP including the possibility of permanent removal from the RWLP.

(O) If, for any justifiable reason, tow truck operators are unable to respond when summoned, or, when the towing company knows they will be unable to service tow requests for a certain number of days, they will immediately notify the Hammond Police Department and have themselves "inactivated" on the tow rotation and shall not summon a substitute. Repeated instances of a tow company failing to respond may subject the tow company to be removed from the RWLP.

(P) If a tow truck arrives at the scene and is unable to provide the necessary services, the tow company must immediately notify the Hammond Police Department. The tow company shall not summon a substitute unless the other tow truck is from the same company. The tow company may request the assistance of another tow company on the RWLP if needed. This request should be made and approved through the on scene Hammond Police officer.

(Q) Interference with law enforcement officers at the scene or failure to comply with an officer's lawful instructions is prohibited. No tow truck operator or tow company should follow a directive or order that is unsafe or beyond the operational standard or capacity of any equipment being used in cleanup or in removing the roadway hazard and, as such, should not face adverse action by the department.

(R) No tow company operator shall charge for services not performed or make duplicate charges.

(S) No tow company operator shall make repairs or alterations to wrecked or disabled vehicles without prior authorization of the owner except for that which is necessary in an emergency to permit vehicle towing.

(T) Operators must notify the Hammond Police Department before proceeding to any call from a motorist when the call may involve a crash or an impaired driver.

(U) Operators shall comply with the provisions set forth in, Louisiana Revised Statutes 32:1711 et seq. and Louisiana Administrative Code 55:1901 et seq., relative to the storage and release of motor vehicles.

(V) Penalties for Towing Violations.

(1) The Chief of Police or his designee shall investigate all complaints against persons operating a wrecker service in order to maintain compliance with this ordinance.

(2) The Chief of Police is authorized to enforce the provisions of this ordinance, and is directed to cooperate with applicable State agencies relative to compliance with towing, recovery and storage rules and regulations of that agency. In addition thereto, the Chief of Police is authorized to suspend or remove any wrecker service or tow truck operator from the RWLP due to the failure to adhere to this ordinance and Hammond Police Department policies.

(3) Violations of the callout time requirement will result in the following action by the Chief of Police:

- (a) First violation in a twelve (12) month period will result in a letter from the police chief to the owner indicating non-compliance and a request to adherence. Second violation in a 12 month period, is a two (2) rotation suspension from the RWLP. A third violation in a 24 month period will cause a 30 day suspension from the RWLP. Continued non-adherence to this ordinance will result in the towing company being removed from the RWLP.
- (b) Any tow truck owner suspended from the RWLP may submit a written appeal requesting a review of the findings and suspension to the Chief of Police.
- (c) Review hearings will be held by the Chief of Police within ten (10) business days, after the request is made.

(W) Appeal. Any wrecker service suspended or removed from the RWLP may appeal the decision of the Chief of Police to the City Council. The appeal must be in writing and filed with the Council clerk within fifteen (15) days after receipt of notice of suspension or removal.

I am also concerned that the projects discussed have never been published in the official journal or attached to the Council agenda. Instead, the total amount of bonds proposed and the project list have changed several times in the course of a single month.

Good government listens to the people and works to ensure understanding and participation.

I urge you to uphold my veto of this ordinance.

AN ORDINANCE TO AMEND THE UNIFIED DEVELOPMENT  
CODE REGARDING POLITICAL SIGNS

BE IT ORDAINED by the City of Hammond City Council that:

Section 1: The Unified Development Code Article 13 section 13.1.10 be amended to read as follows:

+++++

Article 13

...

13.1.10 Temporary signs

- A. Temporary signs are those that generally are not allowed by this article but which may be displayed for periods of no more than fourteen (14) consecutive days upon receiving written prior approval from the building official. Temporary signs may be approved for periods of up to fourteen (14) consecutive days, two (2) times per calendar year, for any one business. No one business then may display temporary signs for more than twenty-eight (28) days per calendar year.
- B. Temporary signs that may be approved shall be limited to:
- (1) Banner signs that announce special events relating to public purposes, charity, non-profit entities, or tourism. Such signs approved by the building official may be erected across public streets that are no more than two (2) lanes wide.
  - (2) Portable or trailer signs that display grand openings or "special events."
  - (3) Signs painted or built onto vehicles to be parked as advertising.
- C. It should be noted that this article allows many types of temporary signs that do not need approval from the building official. An example would be a business that announces a special sale with a temporary sign on their building or on an approved pole or mobile sign. Such signs do not need prior approval. Real estate, contractor signs, and political campaign signs are also examples of temporary signs that do not need prior written approval from the city when installed according to the guidelines of this article.
- D. Political campaign signs are all considered temporary. These signs are not allowed on public right-of-way, public buildings, public parks, utility poles, or on public trees and may at any time be removed from the public property by the city.
