These services shall be performed only within the corporate limits of the above-named municipality. The above-named municipality hereby agrees that Tangipahoa Parish Government is performing this service at no cost to the City of Hammond. The City of Hammond will be responsible for any preparatory work that is required prior to the aforementioned operations occurring.
