Instructions to Proposers

SCOPE:

It is the intent of the City of Hammond to secure pricing on the **Annual Uniforms for Public Safety** (i.e. the City of Hammond Fire and Police Departments). Proposal prices will be for the purchase of the uniforms used by these two departments. No specific quantities are given or guaranteed. All uniform orders will be placed on an "as needed" basis. This contract shall remain in effect for a period of twelve (12) months from Proposal award date. Contingent upon the ability of the successful proposer to honor the quoted proposed prices, the City reserves the right to renew the existing contract for an additional two twelve (12) month periods.

The following proposal specifications are to be used as minimum and maximum standards for the Annual Uniforms for Public Safety, for use by The City of Hammond Fire and Police Departments. All quoted products shall either meet or exceed the following proposal specifications. Unless otherwise stated, the use of manufacturer's name and product numbers are for descriptive purposes and to establish general quality levels only, they are not intended to be restrictive. All products being proposed shall be new and un-used only.

INITIAL MEASUREMENTS:

Initial measurements shall be made at the department locations to be designated by the City after proposal has been awarded. Measurements shall be performed on an "as needed" basis at the designated locations without disruption of the normal operation of the City departments. The successful proposer shall be responsible for coordinating a time schedule with City department heads for employee measurements.

ALTERATIONS:

All alterations shall be performed in a timely manner and shall be performed to the satisfaction of the City employee for whom the garment is intended. All alterations shall be at NO COST to the City of Hammond and its using departments.

EMBLEMS:

All patches and rank stripes (hash marks) shall be furnished by the City of Hammond Fire and Police Departments to the vendor to whom proposal has been awarded (unless patches are ordered through vendor). Successful proposer is responsible for sewing on the appropriate patches and rank stripes to each uniform garment ordered at NO additional cost to the City of Hammond.

EMBROIDERIES:

Embroideries will be an additional charge depending on both location, size and department needs.

COLORS:

Unless otherwise designated, colors shall be selected by the using department(s) prior to order placement.

PURCHASE AGREEMENT

This PURCHASE AGREEMENT ("Agreement") is made this ___ day of _____ 20__ ("Effective Date") by and between City of Hammond, with offices at 310 East Charles Street, Hammond, LA 70404 ("Customer"), and Galls, LLC, a Delaware limited liability company with offices at 1340 Russell Cave Road, Lexington, Kentucky 40505 ("Company").

1. Purchases. Subject to the terms and conditions of this Agreement, Company agrees to sell and Customer agrees to purchase, upon purchase orders submitted from time to time during the Term, as defined herein, the merchandise listed on Schedule 1 ("Merchandise") at the prices listed on Schedule 1 attached hereto ("Prices").

2. Term. The initial term of this Agreement shall be for 1 year from the Effective Date with the option for two one-year extensions ("Term").

3. Shipping and Returns. The Prices are inclusive of shipping costs. Customer shall inspect all Merchandise promptly upon receipt and will notify the Company of any defective Merchandise within 72 hours after receipt. Customer will either hold such Merchandise for the Company's pick-up or return such Merchandise to Company within 30 days, at Company's election. Returns will be accepted on unworn Merchandise in resalable condition, other than custom or specifically manufactured, personalized, modified, or altered Merchandise, for 30 days after shipment. Customer shall be responsible for the cost of such return shipments unless the need to return is due to Company's production errors or manufacturer workmanship. Returns will not be accepted except in accordance with this Paragraph 3.

4. Payment and Taxes. For every order of Merchandise, the Company will date and send an invoice to Customer (either by mail or electronic transmission, including email or other electronic means acceptable to the Company) on or after the date the Merchandise is shipped to Customer. Payment terms are net 30 days from the date of invoice. Invoices will cover only Merchandise ordered by Customer's representatives in accordance with this Agreement. Any sales tax on purchases by Customer pursuant to this Agreement shall be paid by Customer. Tax deferred certificates are to be provided by Customer for tax payment purposes, if applicable.

5. Termination. Either party may terminate the agreement:

(A) Immediately upon written notice if the other party files a petition for bankruptcy or is otherwise adjudicated bankrupt, or a petition for bankruptcy is filed against the other party and such petition is not dismissed within 60 days, or the other party becomes insolvent, discontinues its business, or voluntarily submits to, or is ordered by the bankruptcy court to undergo, liquidation pursuant to Chapter 7 of the Bankruptcy Code.

(B) Upon 45 days' prior written notice in the event of the other party's material breach of this Agreement. Customer's failure to timely pay any undisputed invoice submitted by the Company hereunder is a material breach of this Agreement.

(C) In the event Customer seeks to terminate this Agreement for material deficiencies in service and/or quality of Merchandise provided, Company is afforded 45 days from the date on which Company receives written notification of the deficiency(ies) to correct or begin to take reasonable steps to correct any deficiencies complained of.

6. Title and Risk of Loss. Title and risk of loss with respect to the Merchandise shall pass to Customer when the Merchandise is loaded for shipment onto a truck at the Company's dock.

7. Purchase of Merchandise. Customer acknowledges that Company will make an investment in Merchandise that is unique to Customer and not part of Company's standard product line. Notwithstanding anything to the contrary contained herein, upon (i) any termination of this Agreement in whole or in part, by either party and for any reason, (ii) the final expiration of this Agreement, or (iii) the Customer's change in the specifications of any Merchandise, Customer shall purchase from Company: all Merchandise (or the applicable Merchandise in the case of a specification change) in stock or committed by Company to Customer (whether shelf inventory, manufacturers' supplies ordered by Company, or otherwise); all work in process (once completed); and all fabric and raw materials purchased by Company (or its suppliers) for the production of such Merchandise. The purchase price for such Merchandise shall be the Prices then in effect under this Agreement. The purchase price for such fabric and raw materials will be at Company's (or its suppliers') cost as evidenced by mill invoices. Notwithstanding the foregoing, Customer shall only be required to purchase Merchandise that is of first quality and salable as new. Customer shall be responsible for payment of freight with respect to all Merchandise, fabric, and raw materials purchased pursuant to this Paragraph 7.

8. Purchase of Other Requested Merchandise. In the event Customer desires to order merchandise that is not listed on Schedule 1, the Company shall provide Customer with prices for such merchandise, and Schedule 1 shall be amended by mutual agreement of the parties. To the extent such merchandise is not a standard product regularly stocked by Company, Customer hereby agrees to purchase all such merchandise in the ordinary course of business; *provided that* should Customer cease making regular purchases of any such merchandise for a period of 6 months, or upon any termination or expiration of this Agreement, Customer hereby agrees to purchase all such merchandise pursuant to Paragraph 7.

9. Company's Representations and Warranties. Company represents and warrants that all uniform items manufactured by Company and delivered hereunder (i) are manufactured and sold in compliance with all government laws, rules, and regulations applicable to Company, and (ii) will be manufactured in full compliance with all applicable import regulations established by the US Customs Service and the FTC. THE COMPANY MAKES NO OTHER WARRANTIES WITH RESPECT TO THE MERCHANDISE AND ALL OTHER WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, ARE EXPRESSLY AND SPECIFICALLY EXCLUDED. Customer further acknowledges that no standards or minimum performance requirements have been established for the Merchandise, that it has independently investigated merchandise available to satisfy its needs, and that it has relied on its own investigation and not upon any representations, expressed or implied, by Company.

10. Insurance. Company agrees to procure before the execution of this Agreement, and maintain during the term of this Agreement, the following insurance: statutory worker's compensation insurance, employer's liability insurance, and general liability insurance (to include coverage for public liability and property damage liability) with limits not less than \$5 million combined single limit per occurrence for loss or damage (which may be met through the use of excess/umbrella coverage).

11. Miscellaneous.

11.1. Damages. Under no circumstances shall either party be liable to the other party for any consequential, incidental, special, exemplary, punitive, or other similar damages, however denominated.

11.2 Force Majeure. Neither party shall be liable to the other for any delay or failure to perform hereunder (excluding payment obligations) due to circumstances beyond such party's reasonable control, including acts of God, acts of government, flood, fire, earthquakes, hurricane, tornado, civil unrest, acts of terror, strikes or other labor problems (excluding those involving a party's employees), or service disruptions involving hardware, software, or power systems not within a party's possession or reasonable control.

11.3 Choice of Law and Jurisdiction. This Agreement shall be governed by and construed in accordance with the laws of the State of Louisiana. Each party irrevocably submits to the exclusive jurisdiction of the state and federal courts located in Tangipahoa Parish, Louisiana in connection with any dispute arising out of this Agreement.

11.4 Non-Waiver. No failure by either party to take any action or assert any right hereunder shall be deemed to be a waiver of such right in the event of the continuation of repetition of the circumstances giving rise to such right.

11.5 Power to Bind. Customer has read the forgoing in its entirety, understands all of its terms and conditions, and warrants to Company that the person signing on its behalf has the authority and power to execute this Agreement.

11.6 Entire Agreement. This Agreement, including the attached Schedule 1, constitutes the final, entire, and complete agreement of the parties with respect to the subject matter hereof and supersedes any prior agreement or understanding between or represented by the parties relating to the subject matter. This Agreement shall not be deemed or construed to be modified, amended, rescinded, canceled, or waived, in whole or in part, except by written amendment signed by the parties hereto.

11.7 Assignment of Agreement. This Agreement and all of the provisions hereof shall be binding upon and inure to the benefit of the parties hereto and their respective successors and permitted assigns, but neither this Agreement nor any of the rights, interests or obligations hereunder shall be assigned by any of the parties hereto without the prior written consent of the other parties.

11.8 Execution of Agreement. This Agreement may be executed in two or more counterparts, and each such counterpart shall be deemed an original hereof.
