There was a motion by <u>Councilwoman Gonzales and</u> second by <u>Councilman Andrews</u> to approve Portside Seafood & Grill located at 1750 W. Thomas St. Suite I Hammond, LA 70401 to obtain an alcohol permit for a restaurant. The owner is Portside Seafood & Grill, LLC. **VOTE:** Councilman Andrews (Y), Councilman DiVittorio (Y), Councilwoman Gonzales (Y), Councilman Wells (absent), Councilman Leon (Y). Motion Approved 4-0

4.A resolution 1) supporting the submission of an application for \$1.6 million to the Assistance to Firefighters Grant Program to purchase a new ladder truck for the Hammond Fire Department (HFD); and 2) supporting a cash match of \$145,455 to come from the HFD's millage fund.

Lacy Landrum, stated this is the application stage and they are asking council permission to submit this grant and the one that follows. She explained the grant.

There was a motion by <u>Councilwoman Gonzales and</u> second by <u>Councilman Leon to</u> approve 1) supporting the submission of an application for \$1.6 million to the Assistance to Firefighters Grant Program to purchase a new ladder truck for the Hammond Fire Department (HFD); and 2) supporting a cash match of \$145,455 to come from the HFD's millage fund.

5. A resolution 1) supporting the submission of an application for \$320,000 to the Assistance to Firefighters Grant Program to purchase new turnout gear and gear washers and dryers for the Hammond Fire Department (HFD); and 2) supporting a cash match of \$29,091 to come from the HFD's millage fund.

Lacy Landrum, stated like the previous one this is an application only, it would come back before the council to approve the contract if the grant is awarded. She explained the grant and gear washers and dryers.

There was a motion by <u>Councilman Leon</u> and second by <u>Councilman Andrews</u> to approve a resolution; 1) supporting the submission of an application for \$320,000 to the Assistance to Firefighters Grant Program to purchase new turnout gear and gear washers and dryers for the Hammond Fire Department (HFD); and 2) supporting a cash match of \$29,091 to come from the HFD's millage fund. **VOTE:** Councilman Andrews (Y), Councilman DiVittorio (Y), Councilwoman Gonzales (Y), Councilman Wells (absent), Councilman Leon (Y). Motion Approved 4-0

6. A resolution to reappoint Ken Ross to the Hammond Airport Authority for a five year term ending September 30, 2028

Lacy Landrum, stated he is a current member and is willing to continue to serve. Ken Ross, stated that the airport is a passion of his and he is happy to serve. He stated the airport is on the right course.

There was a motion by <u>Councilwoman Gonzales</u> and second by <u>Councilman DiVittorio</u> to reappoint Ken Ross to the Hammond Airport Authority for a five year term ending September 30, 2028. **VOTE:** Councilman Andrews (Y), Councilman DiVittorio (Y), Councilwoman Gonzales (Y), Councilman Wells (absent), Councilman Leon (Y). Motion Approved 4-0

VIII. REPORTS:

Mayor: Lacy Landrum, stated the received sales tax from December shopping and it was above the budget, which came in around \$2.7 million.

Council: Councilman Andrews, stated the city offices closed on Tuesday for Mardi Gras and to keep Councilman Wells in prayer due to the loss of his aunt.
