#### CITY OF HAMMOND ORDINANCE No. 22-5668 C.S

#### AN ORDINANCE ESTABLISHING A TEMPORARY180 DAY MORATORIUM ON THE ACCEPTANCE AND PROCESSING OF SUBDIVISION PLATS, SITE DEVELOPMENT PLANS OR ZONING AMENDMENTS FOR MULTIFAMILY HOUSING WITHIN THE CITY OF HAMMOND, PROVIDING FOR VARIANCES AND PROVIDING A SEVERABILITY CLAUSE.

WHEREAS, A Housing Advisory Committee was formed in 2020 by the Hammond City Council; and

**WHEREAS**, the Housing Advisory Committee is expected to make recommendations to the City regarding single family housing; and

WHEREAS, Mechanisms and programs that promote the development of high quality, affordable single-family housing in the City, such as developer incentives, private/public partnerships, redevelopment authority implementation and similar projects are in the public interest; and

**WHEREAS,** Other programs, mechanisms, and measures that would assist in revitalizing and stabilizing areas of the City for single family housing, including infrastructure that would create more complete, connected, safe and attractive residential neighborhoods is in the public interest; and

WHEREAS, the City wants to insure that the impact of future development of multi-family housing has an acceptable impact on the distinctive character of the single family neighborhoods of the City; and

**WHEREAS**, the City will change drastically if unlimited growth of development of multi-family housing projects should occur under the City's existing ordinances, before the City can review and consider the recommendations of the Housing Advisory Committee; and

WHEREAS, the City Council has determined that it is necessary to study the recommendations of the Housing Advisory Committee and update its development ordinances and procedures as determined appropriate to meet the housing needs of City's citizens, and to protect the health, safety, environment, quality of life, and general welfare; and

WHEREAS, in order for the City to have adequate and reasonable time to review, evaluate and revise the City's development ordinances, as appropriate, and to consider the impact of the ordinances upon future growth, public health and safety, development, the environment, the historic character of the City's neighborhoods and places of importance and significance within the City, the City wishes to implement a moratorium period of 180 days, during which no applications for multi-family housing projects or subdivision plats will be accepted; and

WHEREAS, the purposes of prohibiting applications, for multi-family development permits and/or approvals during this study period include, within limitation, preserving the status quo during the planning process, eliminating incentives for hasty applications, facilitating thoughtful and consistent planning, avoiding exploitation of the delays inherent in the municipal legislative process, and preventing applications from undermining the effectiveness of the revised ordinances by applying for permits and/or approvals in order to avoid the application of new, possibly more restrictive, development ordinances; and WHEREAS, in recognition of the appropriateness of multi-family development permits and/or approvals to the community, the City desires to implement this moratorium for a stated and fixed time period, and to include a variance provision for cases of necessity and undue hardship.

#### THEREFORE, BE IT ORDAINED:

- Except as provided below, no applications for multi-family subdivision plats, multi-family site development plans, multi-family building permits or zoning amendments to change from single family zoning to a zoning allowing multi-family development, will be accepted for fling or processed and no such permits or approvals will be issued by the City until (a) 180 days after final adoption of this ordinance, or (b) termination of this ordinance by the City Council, whichever is sooner.
- 2. This moratorium shall not apply to applications within an area zoned Mixed Use, where the use is at least fifty (50%) non-residential.
- 3. This moratorium shall not apply to applications submitted on or before February 8, 2022.
- 4. An owner of property within the City may request a variance from the requirements of this ordinance under the following conditions:
  - (a) special circumstances or conditions exist imposing an undue hardship on the property owner: or
  - (b) where a multi-family project is in the public interest for that particular area and will not disturb the character of the neighborhood; or
  - (c) there is a previously existing legal right to proceed; or
  - (d) a re-zoning of the property would not result in a multi-family development..
- 5. A written application setting forth the basis for the requested variance must be submitted to the City Planning and Zoning Commission for its recommendation and final approval by the City Council by resolution upon a majority vote of the City Council. A variance may be granted by the City Council if it finds that special circumstances or conditions affecting the property in question justify the variance, and that the adverse effect on the accomplishment of the goals of the moratorium established by this ordinance. Any request for a variance must be submitted to the City Council at least seven (7) days prior in the date of the City Council meeting at which the request is to be considered.
- 6. As used herein, the term "multi-family" shall mean a development of three (3) or more contiguous two-family or duplex dwelling site or a single site with multi-family dwelling.
- 7. In the case of any conflict between the other provisions of this ordinance and any existing ordinance of the City, the provisions of this ordinance will control.
- 8. If any provision of this ordinance or the application thereof to any person or circumstances is held invalid, that invalidity or the unenforceability will not affect any other provisions or applications of this ordinance that can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are severable.
- 9. This ordinance shall be effective as of the date of final adoption.

WHEREAS, Louisiana law requires the City of Hammond to declare whether its existing districting plan is malapportioned following a federal decennial census;

The current districting plan of single member districts of the City of Hammond is malapportioned utilizing the population data from the 2020 federal decennial census, and the City of Hammond shall adopt a new districting plan for use in the next regularly scheduled election.

The City of Hammond authorizes and directs Strategic Demographics, LLC to further proceed with crafting a redistricting plan.



#### AN ORDINANCE TO AMEND SECTION 6 OF THE UNIFIED DEVELOPEMNT CODE REGARDING BOATS ON TRAILERS

**BE IT ORDAINED** by the Hammond City Council that Article 6 Section 6.1.1 of the City Unified Development Code be revised to read as follows:

#### 6.1 Purpose and Permitted Uses in Each Zoning District

#### 6.1.1 Residential Single-Family.

The Residential Single Family Districts are intended to accommodate single-family houses on individual lots. These districts should be applied in areas where the land use pattern is predominately single-family residential or where such land use pattern is desired in the future. These districts allow residential cluster development with smaller minimum lot sizes and additional building types in exchange for protecting significant common open space. For all Residential Single Family Districts, no outdoor storage is permitted in front, side, or rear areas visible from the street, except in enclosed areas such as a garage. This includes storage in the following areas: front or side porches, carports and breezeways, or storage on a trailer. Notwithstanding the above, boats on trailers may be stored on driveways or approved hard surface. Storage of brush, fence posts, crates, vehicle tires, vehicle bodies or parts, scrap metal, bed mattress or springs, water heater or other household appliances, damages, stored or discarded furniture and other household goods or items, material recovered from demolition or other discarded objects three (3) feet or more in length shall not be allowed or permitted on the premises. Temporary storage of items that include trash, leaves, brush, and refuse, for not more than seven (7) days that are being discarded or removed from the premises, will not be in violation of this part.

#### CITY OF HAMMOND ORDINANCE No. 22-5674 C.S.

#### An Ordinance to Amend the Hammond Unified Development Code To Add the Suburban Highway Overlay District

WHEREAS, upon the recommendation of the Hammond Planning & Zoning Commission that an additional overlay district be created in the City of Hammond, the Hammond Unified Development Code be amended to add an additional overlay district called the Suburban Highway Overlay District (SH); as recommended by the city planner.

**BE IT ORDAINED** by the City Council of Hammond, Louisiana, that the Hammond Unified Development Code, Article 8 be amended to add Section 8.6 as follows:

#### **Article 8. Overlay Districts**

....

#### 8.6 Suburban Highway Overlay District (SH)

#### 8.6.1 Purpose

Purpose - In suburban areas along Major Highways there is a need for a more flexible design for the health, safety, and welfare of City residents. Build-to lines are used in many zoning districts around the country and were created for several reasons. The most crucial reason is for pedestrian accessibility. By ensuring the buildings are close to the street it helps with pedestrian accessibility and safety. However, it also helps the overall design of the city by ensuring buildings are placed on the site to be in scale with the surrounding areas. By having large open areas in front of buildings, such as large parking lots, it creates scaling within the city that doesn't fit within the context of the Comprehensive Plan. This overlay improves site requirements along corridors identified as Major Arterials in the Major Street Plan.

WHEREAS, the members of the City Council of the City of Hammond are elected from single-member districts; and,

WHEREAS, interposing the population data from the 2020 federal decennial census into the current districting plan for the City of Hammond discloses that there are districts within the plan the exceed the acceptable population deviation under the principle of one-person-one-vote; and,

WHEREAS, Louisiana law requires the City of Hammond to declare whether its existing districting plan is malapportioned following a federal decennial census; and,

WHEREAS, the City Council of Hammond has acknowledged that the current, existing district plan is malapportioned utilizing the population data from the 2020 federal decennial census, and the City shall adopt a new districting plan for use in the next regularly scheduled election; and,

WHEREAS, Louisiana law requires that if an unequal apportionment of the municipal population exists, that municipality shall by Ordinance change the boundaries of municipal districts to reflect as nearly as possible an equal apportionment of said population.

#### NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HAMMOND, LOUISIANA:

**§1.** The redistricting plan entitled **City of Hammond Redistricting Plan B** of 2022, as described below and depicted by the attached map and depicted by the shapefiles and block equivalency files submitted to the Louisiana Secretary of State and provided to the City Council of Hammond and the Registrar of Voters of Tangipahoa Parish, be and is hereby adopted and such plan shall be utilized for the next regularly scheduled election for the City of Hammond in accordance with Louisiana law with the description of each district of the Board of Aldermen of the City of Hammond being set forth as follows, and more specifically represented on the maps and electroic shapefiles provided to the City of Hammond, the Registrar of Voters of Tangipahoa and the Louisiana Secretary of State:

- 3. Add \$40,000 from Sales Tax Fund balance to asphalt overlay Tina Drive.
- 4. Add four new police officer positions, one for each patrol shift, (each position costs \$75,265 with salary/benefits) for a total cost of \$301,060 added to the Patrol department budget from the General Fund balance.
- 5. Add sidewalks on East Church (Cherry Chestnut) for \$111,000 from the Sales Tax Fund balance.

### An Ordinance to update Rule XI-6 Information Security of the City's IT Policy and Procedure Manual to include a procedure for reporting an actual or imminent breach of personally identifiable information associated with an OJP-funded program or activity or a federal information system used or operated by the City

**BE IT ORDAINED** by the City Council of Hammond, Louisiana, that the City's Policy and Procedures Manual be amended to delete the stricken text and add the language in bold type below:

#### \*\*\*\*\*

#### **Rule XI-6 Information Security**

#### A. PURPOSE

This policy assigns responsibility for the security of City-wide, departmental, administrative and other critical City of Hammond information. Components of security include confidentiality, availability, and integrity.

#### **B. DEFINITIONS**

#### Information technology resources:

Specific items such as telecommunications devices, computer systems, media, and other equipment, goods, services, and personnel related to the collection, storage or transport of electronic information.

#### Critical data:

Data that is so important to the City of Hammond that the loss or unavailability is unacceptable.

#### **Federal Information System:**

A federal information system is a system used or operated to create, collect, use, process, store, maintain, disseminate, disclose, or dispose of information, in any form, by or for the federal government.

#### **Personally Identifiable Information (PII):**

Personally identifiable information is information that can be used to distinguish or trace an individual's identify, either alone or when combined with other personal or identifying information that is linked or linkable to a specific individual. Some information that is considered to be PII is available in public sources such as telephone books, public websites, and university listings. This type of information is considered to be Public PII and includes, for example, first and last name, address, work telephone number, email address, home telephone number, and general educational credentials. The definition of PII is not anchored to any single category of information or technology. Rather, it requires a case by-case assessment of the specific risk that an individual can be identified. Non-PII can become PII whenever additional information is made publicly available, in any medium and from any source, that, when combined with other available information, could be used to identify an individual.

#### C. APPLICABILITY

This policy applies to all information-collected, and/or processed created, collected, used, processed, stored, maintained, disseminated, disclosed, or disposed of using the City's information technology resources. In the case of PII, applicability also extends to information in any federal information system used or operated by the City.

#### D. POLICY

City Information and information technology resources must be recognized as sensitive and valuable and be protected. Depending on the scope and nature of the information, integrity

constraints and special procedures for access and handling may be required.

One of the fundamental requirements and goals of City information processing, whether manual or automated is to manage a single resource: information. This goal drives all others as the City works to define, manage, guard the integrity of, bring access to, and mobilize this resource. The individual data elements and their interface to the larger process must be protected and managed.

#### E. **PROCEDURES**

Departments shall develop, manage and review their own operating policies and procedures and include information security as part of their department's processes. Integrity constraints, procedures that ensure correct processing of correct data, shall be written as departmental procedure. Such procedures should be reviewed as required, at least once a year.

#### **Actual or Imminent Breach of PII**

In the event of an actual breach or the detection of an imminent breach of PII, the IT Director shall be immediately notified. The IT Director shall then immediately notify the Mayor or, in his/her absence, the Director of Administration of the actual or imminent breach and take action to limit further exposure of PII and to protect the City's information technology resources.

No later than 24 hours after an occurrence of an actual breach or the detection of an imminent breach of PII 1) associated with an Office of Justice Programs (OJP)-funded program or activity or 2) in any federal information system used or operated by the City, the IT Director and/or the Grants Director shall notify an OJP Program Manager of the actual or imminent breach.

#### F. **RESPONSIBILITIES**

The IT department is responsible for:

- Ensuring the security, confidentiality, and availability of data and software stored on individual computers and on centrally-managed computer systems.
- Ensuring the backup of critical data and software
- Providing account management
- Establishing and maintaining the physical security of the central computing facilities.
- Establishing and maintaining the physical security of the communications network.
- Establishing and maintaining the physical security of data for which the Information Technology Department (IT) is the custodian.

This policy also places responsibility on TEAM Leaders to:

- Encourage appropriate computer use as specified in the Appropriate Use of Information Technology Resources policy
- Ensure compliance with information technology policies and standards by people and services under their control
- Implement and monitor additional procedures as necessary to provide appropriate security of information and technology resources within their area of responsibility.

#### G. SANCTIONS

Sanctions will be commensurate with the severity and/or frequency of the offense and may include termination of employment; however, termination of employment does not fall under the realm of the IT department.

#### H. EXCLUSIONS

None.

#### I. INTERPRETATION

Authority to interpret this policy rests with the Mayor and Director of Administration, and is generally delegated to the Director of the IT department.

...

(b) The proposed development will reinforce the existing or planned character of the neighborhood.

(c) The capacity of public facilities and services including schools, roads, recreation facilities, wastewater treatment, water supply and stormwater facilities, police, fire and emergency medical services.(d) The subdivision demonstrates:

(1) Compliance with any prior approvals;

(2) Subdivision design appropriate for and tailored to the unique natural characteristics of the site;
(3) Adequate, safe and convenient arrangement of access, pedestrian circulation facilities, bicycle facilities, roadways, driveways, and off-street parking, stacking and loading space;

(4) Adequate design of grades, paving, gutters, drainage and treatment of turf to handle stormwater; and

(5) Adequate access for disabled or handicapped residents through the provision of special parking spaces, accessible routes between parking areas and buildings, passenger loading zones and access to other facilities.

(6) Any adverse impacts on adjacent properties have been minimized or mitigated. With respect to a proposed development that requires a new passage through a residential subdivision, primary consideration shall be given to the impact on the existing subdivision and the comments received from the residents of the impacted subdivision. 
