**Lacy Landrum**, Director of Administration, stated that was a housekeeping item and explained the item. She stated that this will bring the City of Hammond into alignment with the state law so that we will have this resolution on file.

**There was a motion by** <u>Councilwoman Carlee Gonzales</u> and second by <u>Councilman DiVittorio</u> to adopt a resolution assuming responsibility and liability for inspections conducted by City of Hammond Fire Prevention Bureau as provided by law.

2. A resolution to ratify and award bids received 04/04/2024 for "Mooney RCB Crossing W2-L2D"-project no. 420-12405.

**Lacy Landrum** explained the items attachments and the bid process. They are asking that the bid be awarded to the low bidder, Warner Construction in the amount of \$464,763.00.

Councilwoman Gonzales asked to be reminded of what this item was.

Lacy Landrum stated that this was a part of the canal crossings in District 3.

3. A resolution authorizing the Mayor to enter into a Master Services Agreement with Burns & McDonnell Engineering Company for "Engineering Services at the Hammond Northshore Regional Airport."

Lacy Landrum explained the handout of the scores of proposals they received. She stated they go through this process every three to five years in selecting dedicated engineers to handle all the airport project. This is a specialized request for qualifications that are required by the Federal Aviation Administration and the Louisiana DOTD aviation office. They received five proposals and Burns & McDonnell Engineering Company scored the highest and met the qualifications. This doesn't have a monetary value associated with this item. This is just approving them to be the engineers that work on the projects. This will be the engineer of record for the airport projects.

There was a motion by <u>Councilman DiVittorio</u> and second by <u>Councilman Andrews</u> authorizing the Mayor to enter into a Master Services Agreement with Burns & McDonnell Engineering Company for "Engineering Services at the Hammond Northshore Regional Airport."

This purchase will be made with funds from the City's FY22 and FY23 Edward Byrne Memorial Justice Assistance Grants (Projects 22404 and 22403 respectively), specifically awarded for the purchase of portable radios.

Lacy Landrum explained the attached quotes. The City Council has already approved the awarding of two of these grant. The radios are under state contract and is within budget.

She explained the grant and the match requirement and that they are using the grant match fund.
