Escort Required

1. The Contractor shall be required to provide for a properly trained and properly equipped Escort to communicate with the Air Traffic Control Tower to coordinate crossings of Runway 13-31 and travel through other movement areas of the Airport.
2. This Escort shall be entirely devoted to this task for the duration of Additive Alternate 1.
3. Air Traffic Control Tower staff will provide and/or confirm proper training, radio frequencies, call signs, movement areas, etc.
