VII. INTRODUCTION OF ORDINANCE:

1. Introduction of an ordinance to transfer \$15,000.00 from the Downtown Development District Fund (207) Balance to the 'Digital Gateway Project' account (12327).

Michelle Kendall, stated the additional fund are needed to complete the project. This is a collaboration between the city and the Downtown Development District. The city hasd dedicated \$75,000 and the Downtown Development's contribution was \$50,000 this request is to increase that amount due to additional fees that wasn't allotted for the project. The \$15,000 will come from the DDD's budget and are needed to complete the project.

There was a motion by <u>Councilman Andrews</u> and second by <u>Councilwoman Gonzales</u> to introduce an ordinance to transfer \$15,000.00 from the Downtown Development District Fund (207) Balance to the 'Digital Gateway Project' account (12327).

1. A resolution to re-appoint Ms. Phyllis McCraney, to the Hammond Municipal Fire and Police Civil Service Board for a three-year term ending from August 13, 2024 to August 13, 2027. (Councilman Kip Andrews)

Councilman Andrews thanked Phyllis McCraney for her willingness to serve another term.

There was a motion by <u>Councilman Andrews</u> and second by <u>Councilwoman Gonzales</u> to re-appoint Phyllis McCraney to the Hammond Municipal Fire and Police Civil Service Board for a three-year term from August 13, 2024 to August 13, 2027.

2. A resolution to authorize the Mayor to renew the 3 year agreement with Softchoice Corporation for Microsoft Software, in the amount of \$49,982.22 per year.

3. A resolution to authorize the Mayor to renew the Google Work Space Business Plus license agreement for a three year term. The proposed three year contract is an upgrade to Workspace Enterprise Standard which gives the city more storage. The cost is \$41,400.00 per year.

Mayor Panepinto, explained the agreement.

Councilman Wells asked the Mayor to explain the difference between this item and the previous one. **Mayor Panepinto**, explained the difference and uses.

There was a motion by <u>Councilman Leon</u> and second by <u>Councilman Andrews</u> to authorize the Mayor to renew the Google Work Space Business Plus license agreement for a three-year term. The proposed three-year contract is an upgrade to Workspace Enterprise Standard which gives the city more storage. The cost is \$41,400.00 per year.

Mayor Panepinto, stated this was approved in the budget and this is a state contract.

Councilman DiVittorio, stated that he wants to see local dealerships getting the contracts if they can match the price.

Councilman Wells, asked about tracking devices for city vehicles and equipment

Mayor Panepinto, stated they are waiting on information from the state.

There was a motion by <u>Councilman Andrews</u> and second by <u>Councilwoman Gonzales</u> to authorize the purchase of a 2024 F350 Utility Crane Truck for the Water & Sewer department from Courtesy Automotive Group for \$98,549,09 State Contract #4400023793.

Mayor Panepinto, stated that this is a state contract and they were unable to get any 2024's locally. **Sal Nicolosi**, 3607 Hwy 190 w, asked about the vehicles and if they were replacing old vehicles.

Mayor stated they were and explained.

John Pierre, 903 Rue St Michael asked about the vehicles being replaced.

Lt. Daniel Boudreaux, Hammond Police Department, described the vehicle and explained their use.

Councilman Wells, thanked Lt. Boudreaux for coming to the meeting and explaining the item.

There was a motion by <u>Councilwoman Gonzales</u> and second by <u>Councilman Leon</u> to authorize the purchase of four K-9 package Chevrolet Silverado PPV trucks from Gerry Lane Chevrolet for a total amount of \$293,493.88. State Contract #4400023794

Mayor: No Report

Council:

Councilman DiVittorio, raised an issue regarding a permit and duplex being constructed in Villa West. He read from a statement that he wrote.

Mayor Panepinto, explained the position of the permit department and action taken. He stated they addressed it once it came to their attention and the city attorney has been on top of the issue.

Councilman Wells, express his concerned regarding the signature on the permit.

Mayor Panepinto explained the building department process and the use of electronic signatures, but the appropriate people checked the driveway.

Joanne Tallo, resident of Villa West, she raised the concern about a possible duplex in her neighborhood and what is going to happen next.

Mayor Panepinto, explained that this was an RS 11 single family zoning and that can't happen.

City Attorney, Andre Coudrain explained that the owner was sent a letter advising of the zoning and that duplexes are not allowed and if he operates as a duplex he is in violation and there will be enforment. He also spoke with the realtor to have the listing removed.

Joel Crawford, live in the neighborhood of Villa West, provided information on the house.

John Pierre, talked about the neighborhood.

Cindy Grega, 1108 Rue Chalet, asked about the permit process.

Councilman Wells, asked that if the parish is involved, why is there not an agreement, stating that the parish is involved.

Robert Marino, 1003 Rue Chalet, his concern is for safety issues.

Mike Barnholdt, 805 Del Mar, asked about the permit.

Councilman DiVittorio, would like to have this topic related to permit number 202408731 as the first topic under new business at the next Council meeting.

Councilman Wells, asked Mr. James and ex-employee of the recreation department to stand and he requested his personnel file. He ask that they give him his file.
