1—Revised “Bid Proposal Form”

Submission of the attached revised “Louisiana Uniform Public Work Bid Form” shall constitute acknowledgement of this Addendum No. 1.

2— Clarification - “Contract Time, Liquidated Damages, Builder’s Risk and Sidewalk Joints”

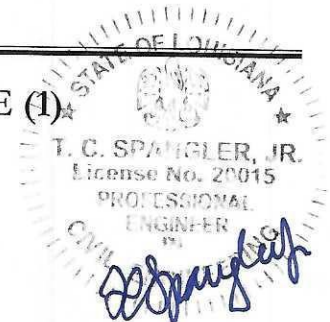
-- Contract time of one-hundred twenty (120) calendar days referenced in Article 9.01 of “Instructions to Bidders” shall be changed to **one-hundred fifty (150)** calendar days. All further references to contract time shall be **one-hundred fifty (150)** calendar days.

-- Liquidated damages of five-hundred dollars (\$500.00) per calendar day referenced in Article 10.01 of “Instructions to Bidders” shall be changed to **two-hundred dollars (\$200.00)** per calendar day. All further references to liquidated damages shall be **two-hundred dollars (\$200.00)** per calendar day.

-- Article SC-6.05 of “Supplementary Conditions” shall be deleted from the specifications. Builder’s Risk is not required for the project.

--Option for 1” thick “Nomaflex” in Section 2-D of “PCC Sidewalk Technical Specifications” shall be changed to **3/4” thick “Nomaflex”**.
