ADDENDUM NUMBER ONE (1)—March 30, 2026

The following additions, clarifications, deletions, and/or corrections to the original Contract Documents are specifically made a part of the Contract Documents with the same force and effect as though originally listed in the original Contract Documents. Any contradictions in these documents shall be immediately pointed out to the Engineer so that a decision and/or clarification can be rendered.

1—REVISED “Bid Form”

--Included herein as “Attachment A – Addendum No. 1” is a revised “Louisiana Uniform Public Work **Bid Form**” for “Lift Station Improvements [FY2025]”, pp. 0400-1 through 0400-4. Remove originally issued pages “0400-1” – “0400-4” and replace/insert the attached revised pages.

Submission of the attached revised “Louisiana Uniform Public Work Bid Form” [pp. 0400-1 through 0400-4] shall constitute acknowledgement of Addendum No. 1.

Please note the addition of Bid Item “21. Install PC Concrete Wet Well (6’Ø)” with the bid quantity of six (6) vertical feet.

2—REVISED “Plan Sheets”

--Included herein as “Attachment B – Addendum No. 1” are REVISED Plan Sheets, totaling 2 sheets (5R and 6R). Remove originally issued plan sheets five (5) and six (6) and insert the attached revised plan sheets.

3—CLARIFICATION – Louisiana Contractor’s License Required

--The required license for this project is Louisiana Contractor’s License, Classification IV – Municipal & Public Works Construction.

4—MODIFICATION – EJCDC C-200, Article 2, Section 2.01

-- In EJCDC C-200 Article 2, Section 2.01 the word “SHALL” is hereby replaced with the word “MAY”. Moreover, Contractors are not required to obtain plan sets from the Issuing Office; however, doing so is strongly encouraged.

5—MODIFICATION – EJCDC C-200, Article 3, Section 3.02.A

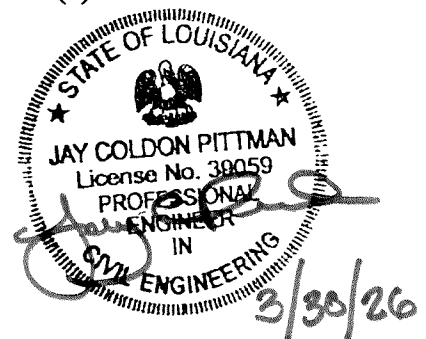
-- In EJCDC C-200 Article 3, Section 3.02.A the following language is delted in its entirety:

“A bid shall be considered “non-responsive” if it is submitted by a party which failed to obtain a serialized set of Bidding Documents from the Issuing Office.”

Moreover, failure to obtain a serialized set of Bidding Documents from the Issuing Office shall not be grounds for deeming a bid non-responsive.

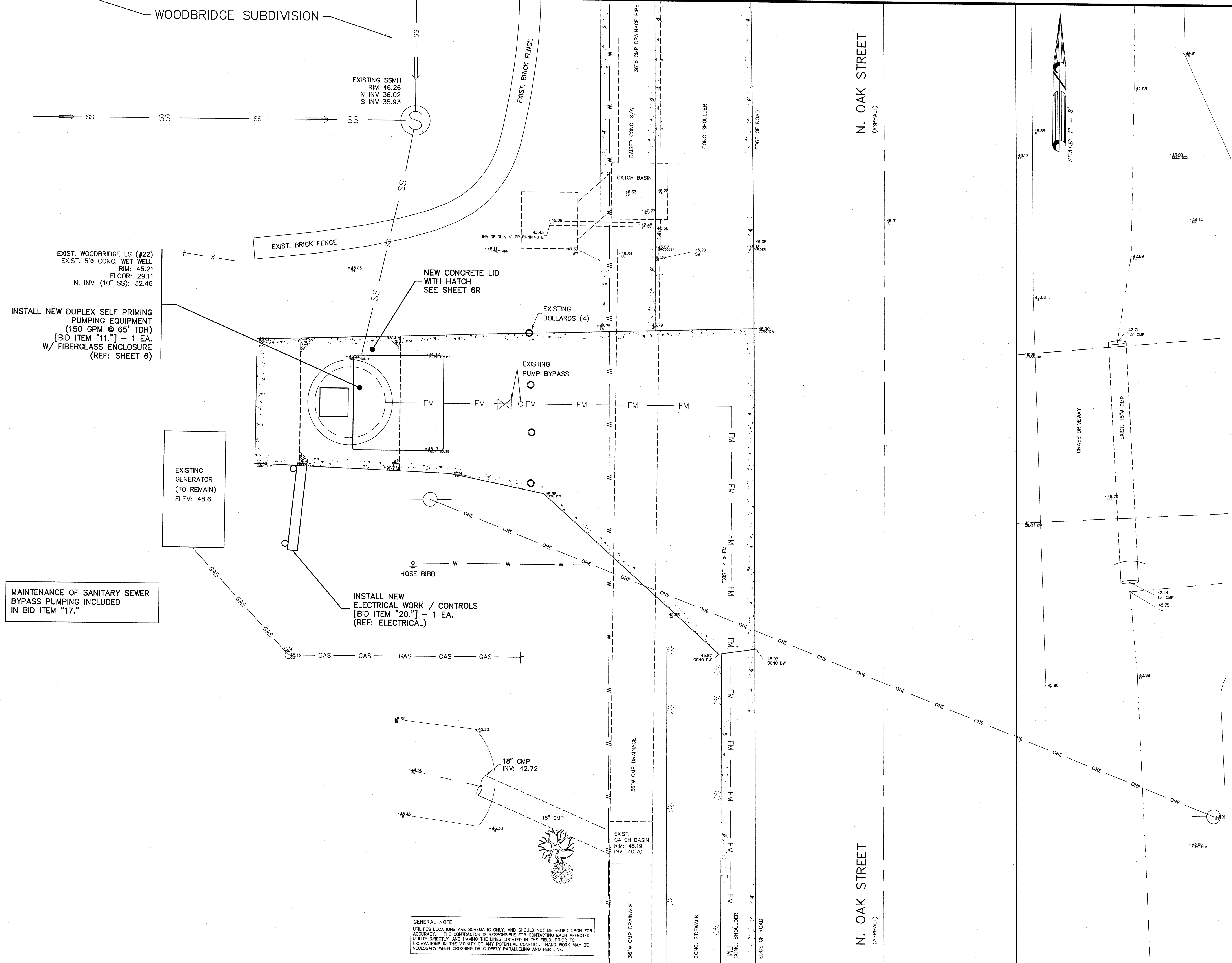

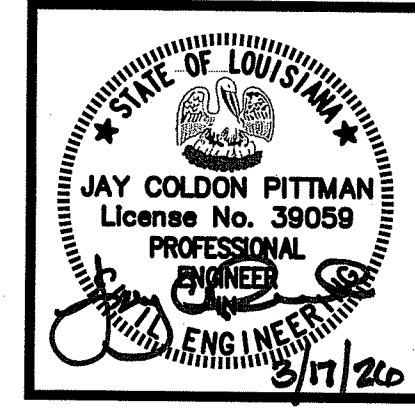

 SITE PLAN

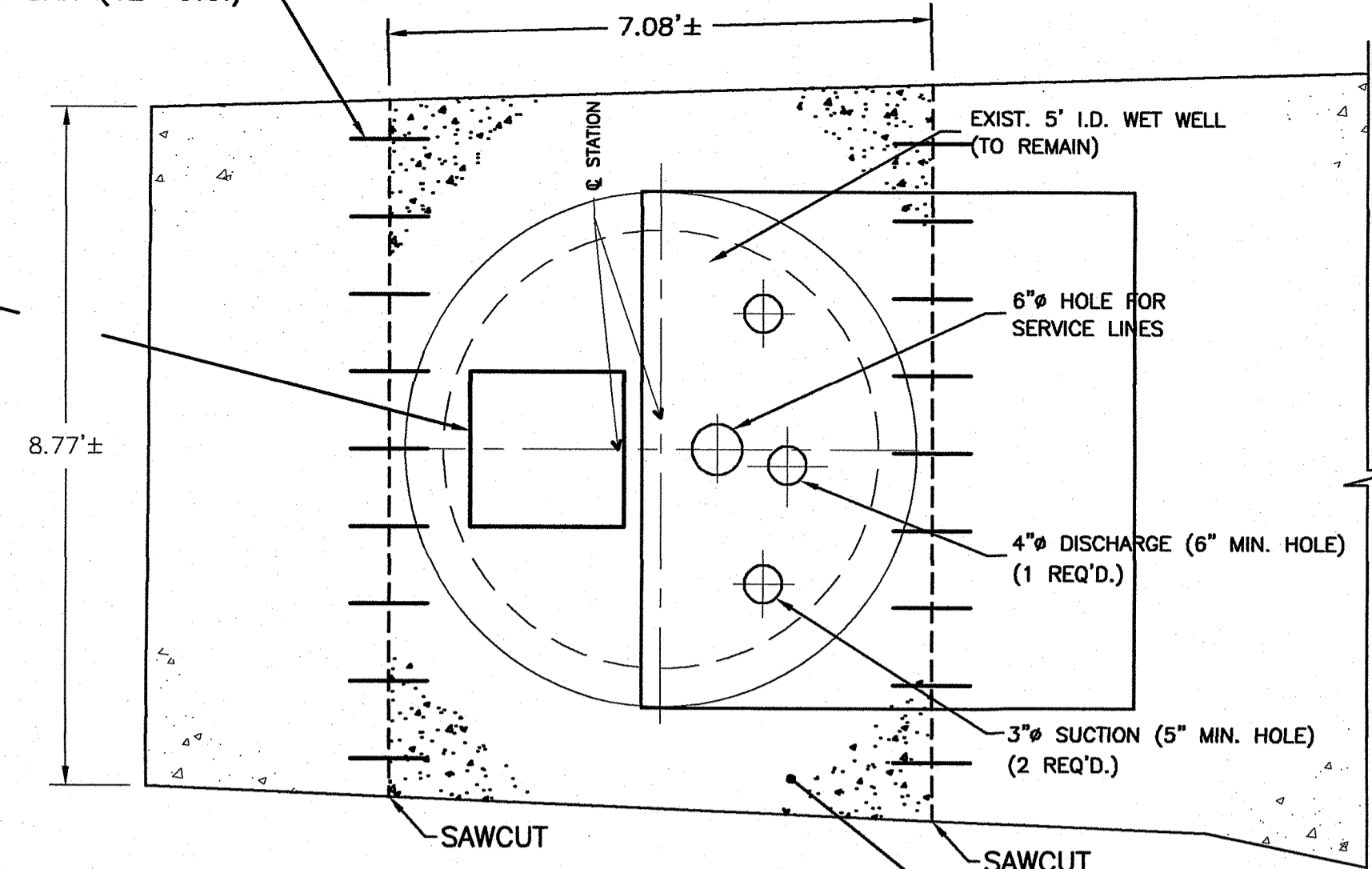

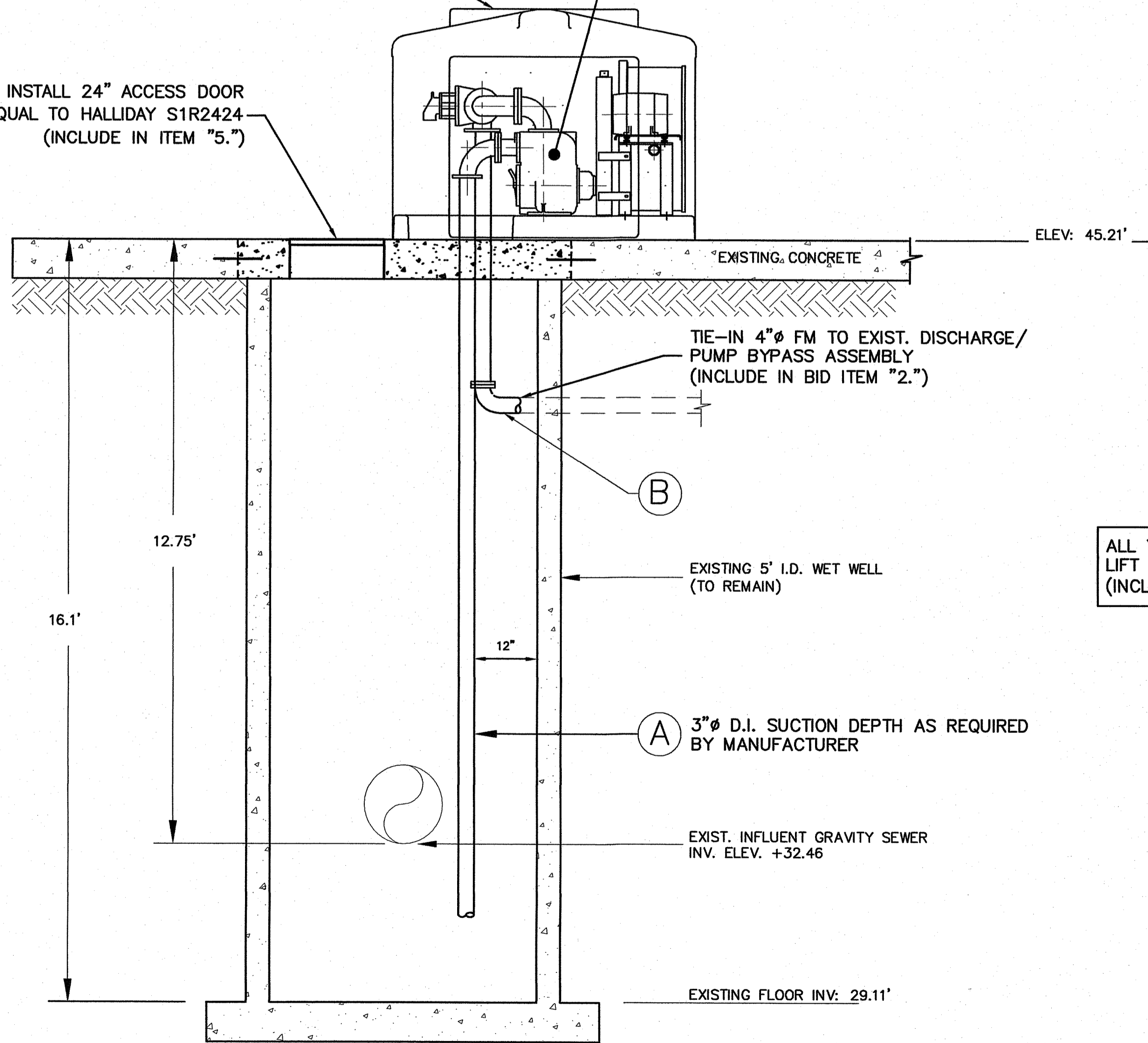

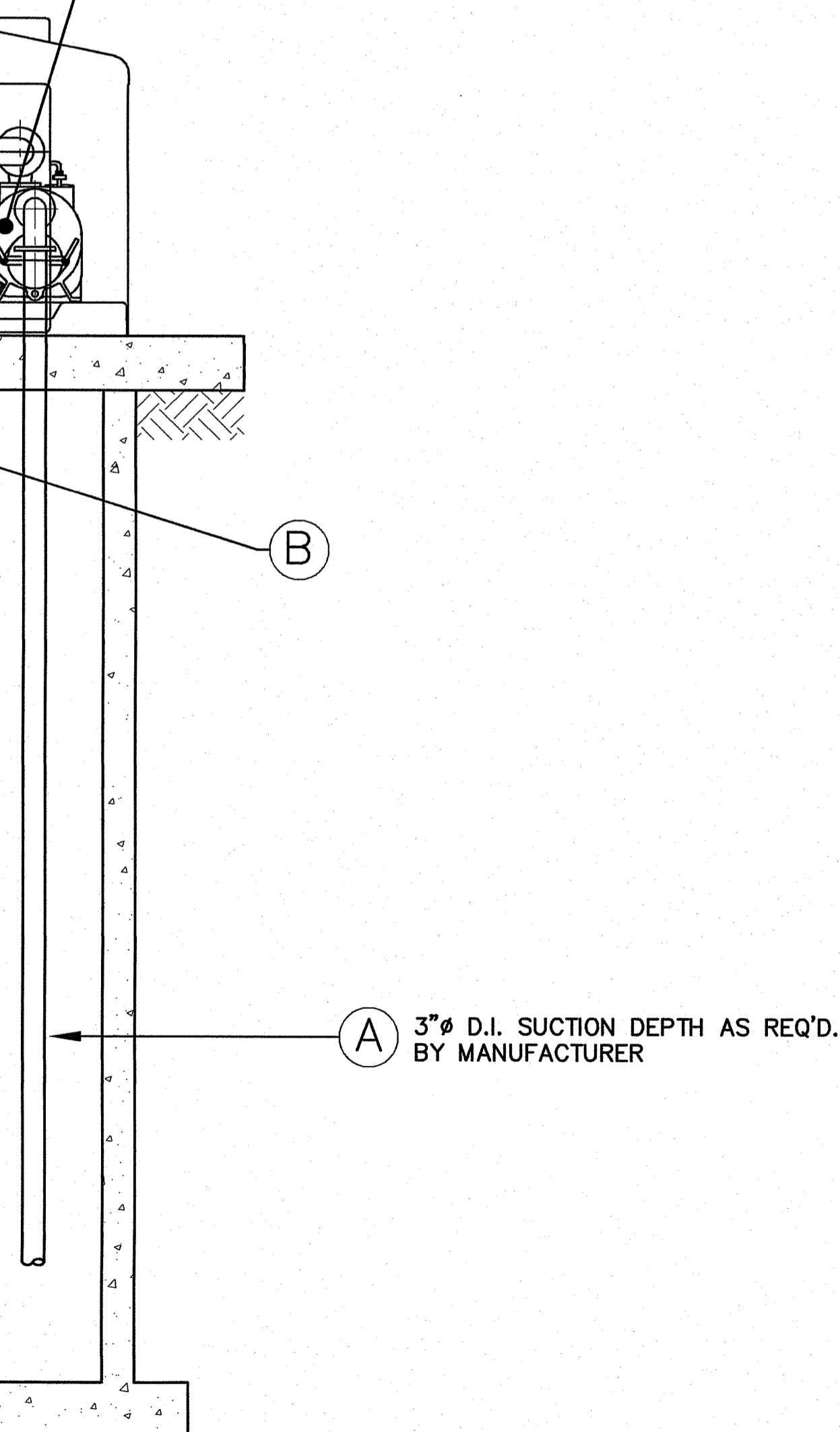

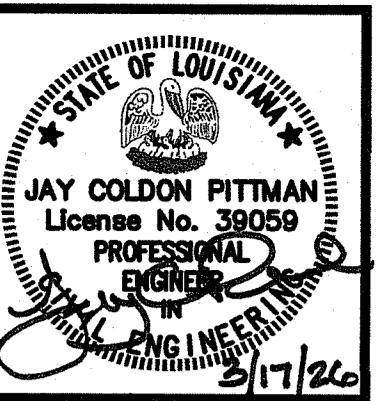
